1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Buyer Added Bid Specific ATC

1. The bidder must upload copies of Income Tax Returns (ITR) Last Three Year.

2. The bidder must be authorized by the OEM to offer products (street lights). The authorization certificate, including the bid number and date, must be enclosed with the bid documents.

3. TDS, BIS for LED street lights and drivers BIS must be enclosed with the bid documents.

4. The manufacturer company is required to submit a notarized certificate on a ₹10 stamp paper stating that no blacklisting action has been taken against the company by any Government / Semi-Government organization during the last five (05) years. Uploading the scanned copy of this certificate is mandatory. Failing this, the bid shall not be considered.

5. The bidder compulsorily upload Last 3 years' CA turnover certificate.

6. A five-year replacement warranty for LED street lights on OEM letterhead With the bid number & Date must be enclosed with the bid documents.

7. Bidder should submit amount- 28000/- Internet Banking Is Accepted only in favour of "Executive Officer Nagar Panchayat Chhutmalpur District Saharanpur.

8. The bidder or firm must attach the latest net worth certificate issued by a Chartered Accountant (CA) with the bid documents.

9. The bidder must upload Latest E-mandate form duly signed by the bank and the bidder.

10. A liquid assets certificate issued by the bank in Last Four Month , showing 5% of the bid v

alue, must be attached with the bid documents.

11. It is compulsory to upload the character certificate of the bidder, issued by the District Magistrate.

12. It is compulsory to upload the OEM's factory license along with the bid documents.

13. ISO 9001:2015, ISO 14001:2015, ISO 45001:2018 & ISO 50001:2018 certificates of the concerned OEM, duly issued by the Bureau of Indian Standards (BIS) Uploaded With The Document.

14- The manufacturing company should obtain a quality management certification license.

15- OEM last 3 yrs. Annual Turnover In Lighting must be uploaded by the bidder.

16. The Company must be approved by UP PWD (E&M) and have a copy of the same must be submitted (AAA Certificate)

17. The Company must have an any NABL (National Accreditation Board for Testing and Calibration Laboratories) lab in India, certified by the Ministry of Science and Commerce with ILAC accredited laboratory equipped with C type photo goniometer as per IES ANSI 2019.

18. Other The Details Of The Bid Is Obtained/Provided From The Department NPP Chhutnalpur.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
