However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

1. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %

2. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

3. Payment Authority and Payment Terms: Payments shall be made to the Seller in the manner below:

- i. **For Goods:** In case of goods, 100% payment will be released within thirty (30) days of

issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills unless otherwise specified in STC / ATC.

- ii. **For Services:** In case of services, 100% payments on the basis of monthly (unless otherwise specified) bills will be paid within thirty (30) days of issue of Service Delivery Acceptance Certificate (SDAC) and on-line submission of bills unless otherwise specified in STC / ATC.

4. "While executing the contract, the contractor shall stand comply with all requirements of Social Accountability Standards i.e. SA8000 (latest Standard available at [www.sa-intl.org](http://www.sa-intl.org)) and maintain the necessary records".

5. Minimum Local Content of this subject package is 60%.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
