1. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

#### ADDITIONAL TERMS & CONDITIONS

These Additional conditions should be read and construed along with Special Terms and conditions of the Gem Portal but in case of any conflict of conditions, Additional terms and conditions of the Department must be followed.

1. The tenderer should submit the following certificate in in readable form and Self signed/Digitally Uploaded, otherwise may result in rejection of tenderer bid: -

A. Undertaking from firms proprietor/Partner on 10 Rs. Stamp paper duly sworn before a magistrate/Notary for non-indulgence in any illegal/mafia/criminal activity or Valid character certificate for contractor issued by D.M.

B. GST Registration copy

C. PAN Card Copy

D. ITR of last three financial year/ Turnover Certificate for CA Firm.

E. The Applicant must be registered in ESI & EPF respectively including Labour department Registration in UP Govt.

F. The Applicant must be registered as Class A contractor in Electrical Safety Department of UP or any other State Govt. or Central Govt. (which shall be verified) extended during the tenure of Agreement.

G. If msme firm then valid certificate.

2. For quoting the Rates, 'Considerably below the estimate value of the tender', the Security Amount, as per decision of the Board of Directors of UPPTCL vide no.353/CS/Transco/cSBD(53)/2017 Dated 11.07.2017, shall have to be deposited by the Tenderer, in whose Name/Favor, Tender is finalized by the competent committee.

3. RATES: - Rates shall be Inclusive of GST.

4. PAYMENT: - 100% payment shall be made to the contractor by Executive Engineer, Electricity Transmission Division, Mathura after successful completion of the work in satisfactory condition if Contractor shall submit 10% of the agreement value as performance guarantee (FDR), If not then 90% as running payment shall be released and remaining 10% kept as performance guarantee and shall be released (FDR or performance guarantee) after 6 months from the date of satisfactory completion of work.

5. COMPLETION PERIOD:-The work shall be completed by the contractor within 30 days from the date of agreement/LOI.

6. DELAY IN COMPLETION OF SUPPLY:- If the contractor fails to execute the Supply within above stipulated time, the penalty @ ½ % per week subject to the maximum 10% shall be deducted. If the contractor fails to execute the Supply after expiry of time as given in the notice served to contractor, the engineer shall get the supply executed from other agency and the excess expenditure so incurred in completion of balance supply shall be recovered from the contractor's pending bill against the agreement or anywhere else.

7. INCOME TAX:- The Corporation shall deduct Income tax as legally applicable from every bill of the contractor as Income tax for remittance of the same to Income tax office as laid down in Income Tax Law. The contractor shall contact Income Tax authorities for refund if any on this account.

8. GST:- GST (CGST/SGST/UTGST/IGST) as legally applicable shall be payable, in accordance with rules & regulation of GST Law, against legal documentary evidence Bills/invoices.

9. EXPERIENCE:- The bidder should have experience of successful execution of similar Supply at 132 KV or above Substation of UPPTCL/PGCIL/Any State Transmission Utility in India. The bidder shall upload the documentary evidence in respect of the experience failing which Part-II of the bid of respective bidder shall not be opened and shall be rejected.

10. Tenders of Black-listed/debarred firms from UPPCL/UPPTCL shall not be considered in any case.

11. T & P AND MANPOWER -All the required T&P including shall be arranged by the contractor on his cost.

12. SPARES & CONSUMABLES: All the Spares shall be arranged by Contractor at his own cost.

13. QUANTITY VARIATION: - Work shall be got executed on one time basis.

I. If the Quality of Work of the firm is poor and the firm fails to execute the awarded work timely, the quantity of awarded work may be reduced to any extent.

II. Within the Agreement value, quantity of individual work may vary to any extent on positive as well as negative side with the condition that total value of agreement shall not exceed.

III. Subject to the condition of satisfactory execution of awarded work, the total value of Agreement may be extended by ±10%.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
