Prospective bidders (if not already registered), are advised to get themselves registered with the said registration authority before bid opening date. GFR following a fair, transparent and reasonable procedure.)

## 2. **Purchase Preference (Centre)**

Bid reserved for Make In India products: Procurement under this bid is reserved for purchase from Class 1 local suppliers as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document 50%. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. ## 7. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

## 8. **Buyer Added Bid Specific ATC**

Additional Terms and Conditions:-

- i. Bidders have to go through the Scope of Work / Specification of the bid. On participation / submission of quotation against the bid means that the firm complies to the Scope of work / Specification of the bid. In case of any non-compliance to the Scope of Work / Specification, the bidder have to specify the same in the bid.
- ii. The job is to be carried out as per HEF specification as attached in the bid. The job is to be carried out strictly as per specifications.
- iii. Being Defence installation, it is very important that people having access to this office should have good character and antecedents. Only PVR cleared individual will be accepted and allowed to work. The same, in original, to be submitted in security section.
- iv. The short term hiring of human resource on full-time basis will be purely on contractual basis and this appointment will not vest any right to claim by the candidate for regular appointment in the factory or automatic extension of contract / agreement.

  - viii. Contractor shall replace the working personal immediately if Factory finds him/her otherwise not suitable.
- ix. Factory shall not be the party to any kind of dispute that may arise between the contractor and contractual individual to be engaged by them.
- x. The contractor shall abide by the provisions of the child labours (prohibition and regulation act 1986).
- xi. The contractor shall not pay wages less than the prevailing minimum wages as fixed by central govt. from time to time during the currency of the contract, to the workers engaged by them. Minimum wages shall mean the rate(s) notified by central government from time to time. The contractor shall maintain necessary records and register like wage book and wage slip, register of unpaid wages and register of fines and deductions mentioning the relevant particulars as required under various statutory provisions.
- xii. The contractor will be liable for making any compensation which may arise in case of any accident to person employed by him against this contract as per ESI schedule. For minor injury while on work financial/medical help shall immediately be given by the contractor.
- xiii. Payment to be made to the contract labour on regular basis on or before 7th of every month as it is a statutory requirement & other statutory requirement should be met as per new labour laws. Any violation of the statutory requirement will lead to cancellation of contract without any advance intimation and the PSD will be forfeited.
- xiv. Any damage caused to the properties and works of HEF by the contractor during his period shall be made good / adequately compensated by the contractor, failing which the same will be made good by the GM/HEF at the risk and cost of the contractor.
- xv. The contractor will not allow or permit his employees to participate in any trade union activities or agitation anywhere in the work place/premises of HEF. If found indulging in such activities, the contract labour will be terminated immediately.

xxv. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
