If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. ### 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. **Buyer Added Bid Specific ATC**

1. The item shall be supplied as per the Specification enclosed. Tender specification shall be submitted along with seal and sign. Deviation in specification if any may be separately attached.
2. Quantity is divisible.
3. The bidder shall offer the price on "F.O.R Salem Steel Plant" basis in GeM portal including P&F charges, Freight & Insurance Charges etc with applicable taxes & duties.
4. The payment shall be "100% within 30 days after receipt and acceptance of the item at Salem Steel Plant Stores".
5. Unless otherwise specified in the tender terms, the inspection will be at Salem Steel Plant after receipt of the consignment.
6. The bidder shall not quote/attach any price/price bid format along with their technical offer. The offer of such bidder will be summarily rejected.

8. The prices shall be kept firm till supplies are completed.
9. Delivery Schedule: 8 weeks from the date of order placement.

11. The bidder shall submit "Form-I-Annexure-I Undertaking on letterhead, Form-II-No Deviation, Form-III Eligibility Criteria Check List and Form-IV Land border certificate and checklist duly signed along with the tender and other documents, as sought in eligibility criteria, along with their technical offer.
