1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the

Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- 1 If the authorized channel partners of the OEM are participating in this bid, then they have to submit the bid specific OEM authorization certificate failing which offer shall be summarily rejected.
- 2 The bidders are required to submit the declaration regarding percentage of local content of the offered product(s) from the OEM failing which their offer shall be liable to be rejected.
- 3 Bidders has/have to comply all the specifications/parameters/conditions as required also submit all required/mentioned declaration/supporting documents.
4. Make and Model offered through GeM Catalogue and through documents submitted along with bid shall be same, failing which offer is liable to be rejected.
- 5 The EMD shall be accepted only through online mode against this bid.
6. Bidders are required to submit the Authentic OEM Datasheet (Not merely the copied version of specifications) clearly depicting the Technical Values and Parameters as required.
7. Bidders are required to submit documents related to Purchase order and Invoices/CRAC for the supply of item KVM Extender of offered make against past experience criteria failing which offer will liable to be rejected. The Bidder/OEM {themselves or through reseller(s)}, should have executed project for supply of SIMILAR ITEMS OF OFFERED MAKE during preceding 3 financial years (i.e. current year and 3 previous financial years) as on opening date of bid. as follows:-
 - i) One order of value atleast Rs. 19,54,000.00/-
 - ii) Two orders of Value atleast Rs. 12,21,000.00/
 - iii) Three orders of Value atleast Rs. 9,77,000.00/-
8. The similar item will be KVM Extender.
9. In case of offers from Micro and Small enterprises/Start-UP (Manufacturer of the product quoted), the value/financial limits applicable for Eligibility criteria for work experience and Eligibility criteria for Average Annual Turnover of OEM/Bidder shall be 75% of the corresponding values for these criteria.
10. Bidders claiming EMD Exemption on the basis of MSE or Start-UP shall be manufacturer of the offered product.
11. Bidders are required to refer to the deviation clause as attached in the Buyer uploaded Bid ATC.
12. Documents available with COS office may considered for evaluations in case required.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
