Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **Generic**

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

Payment Terms:

- (1) 90% of the payment shall be done after certification of EIC on successful erection, commissioning and installation of the system/product and trial run for 07 days. Balance 10% shall be done on completion of warranty period.
- (2) Payment during AMC periods (1st & 2nd year AMC after warranty period) will be done on quarterly visit basis.
- (3) Mode of Payment : Through EFT.
- (4) Freight charges : To be arranged by the vendor.
- (5) Inspection : Materials will be inspected at NSPCL- Durgapur.
- (6) Price Variation: Fixed Price Basis till installation.

(15)Separate Service Purchase Order for 02 years AMC shall be placed before start of AMC.

(16) In Warranty & AMC period, the party has to attend and repair the equipment or give replacement with in 24 hours of reporting of the complaint.

(17) Delivery Point: Agency to deliver the items at NSPCL-Durgapur Site.

(18)Inspection of materials: By Indenting Dept. after receipt of the materials at NSPCL-Durgapur Site.

(19) All other Terms & Conditions as per NSPCL GTC/GCC.

(20) GST: Extra @18% or as applicable at the time of supply of materials.

21) Bid evaluation: Package wise.

INSTALLATION & COMMISSIONING:

(1) The installation and commissioning include fixing of the attendance reader along with the power supply unit and battery back-up system at different locations of NSPCL Durgapur plant .

(2) Civil, Cabling, Power Points, Stable Power, networking, network connections to be provided by NSPCL. Site preparation by NSPCL. Pole and shade to be provided by NSPCL.

(3) Installation of the time attendance software and integration with the face reader.

(7). The agency should deploy the expert manpower for maintenance of the equipment.

(8). Frequency of visits shall be done once in 03 months i.e. 04 visits per year.

(9). Person visiting during comprehensive AMC period shall abide by the safety rules of NSPCL- Durgapur.

(10). The work is to be executed only by the authorized person keeping in view the industrial safety norms and regulations as per the law.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

2. GST shall be included in the AMC Charges quoted.
3. The AMC functionality shall be available in bid only and no direct RA shall be applicable. In case of bid to RA decrement rules shall be applicable on total price inclusive of AMC charges.
 - 3.1 Buyer shall indicate number of years of warranty by selecting option of 1- 10 Years available in the field depending on warranty parameter applicable in category parameters for the equipment. The Seller while participating in Bid/RA will get fields to indicate AMC charges as percentage depending on number of years of AMC selected by Buyer. The following shall be applicable If 5 year AMC selected.

 - 3.2 The calculation of AMC Charges shall take in to account of number of years of warranty and duration of AMC as specified while creating bid.
 - 3.3 AMC charges to be indicated for each subsequent year should be same or higher than preceding year.
 - 3.4 The AMC charges shall be offered within range of 3 to 25% of cost of equipment.
4. Since AMC charges are to be paid only later for each year during AMC period , applicable performance guarantee amount after placement of contract shall be based on the cost of product/equipment and not on basis of cost of equipment along with AMC Charges.
5. Performance bank guarantee applicable for AMC is to be submitted at start of the AMC and shall be applicable as 2.5% on the total contract value including AMC Charges The PBG submitted after award of contract shall be released only after new PBG for the AMC period is submitted and accepted by buyer/consignee after due verification. 7. The AMC Contract shall be an offline contract to be handled by buyer. The payment of AMC will be made on AMC frequency (as indicated above) basis after satisfactory completion of said period, duly certified by end user and scope of AMC will be as per para 1 above.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
