1. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.

2. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.

3. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

- 1. Scope:** Supply, Installation and Commissioning as per Technical Specifications
- 2. Completion Period:** The project is scheduled for completion within **six (6) months** from the date of issue of GeM Contract
- 3. Payment Term:**

100% (hundred percent) payment within 10 days shall be paid upon receipt of CRAC. (Consignee Receipt and Acceptance Certificate)

4. Eligibility Criteria:

A. Technical Eligibility Criteria:

- i.** The Bidder can be an OEM (Original Equipment Manufacturer of Transformers) or Authorized Distributor / Authorized Dealer of the OEM.
- ii.** OEM means any Manufacturer of Transformers mentioned in Approved Make List (enclosed) under Transformer Category - Serial No. 7.1 & 7.2, for capacity above 2 MVA. In case any particular OEM of Transformer (Oil Type & above 2 MVA) is not listed in Make list 2025, then OEM should meet the acceptance criteria as indicated in Make list for qualifying in the bid.
- iii.** In case the bidder is an Authorized Distributor / Authorized Dealer of OEM (as per criteria defined in para A(ii)), a bid-specific authorization certificate from the said OEM must be submitted along with the offer by the bidder.
- iv.** The said OEM shall be responsible for Installation, commissioning and maintenance support as per the defined Scope. If the bidder is an Authorized Distributor / Authorized Dealer, a certificate from the OEM must be submitted confirming that installation, commissioning and maintenance support will be extended by the OEM as and when required.
- v.** The OEM should have service and spares parts support setup in India. The bidder should submit certificate for proof of the same.

B. Financial Eligibility Criteria:

- i.** The average annual financial turnover of the bidder should be at least Rs. 346 Lakhs the last three financial years ending 31st March 2025.
- ii.** Net worth of the bidder shall be positive in the financial year ending 31st March-2025 as per Audited Annual financial reports.
- iii.** The bidder is required to submit Audited Annual Accounts (relevant pages of Balance sheet and Profit Loss statement) for the last three (3) consecutive financial years ending 31st March 2025 in support of the above and the same must contain Unique Document Identification Number (UDIN).
- iv.** **In case documents Audited Annual Accounts as mentioned at point B(iii) above are not available due to genuine reasons**, the bidder is required to submit "Turnover and Profit & Loss Certificate" which is to be issued by Chartered Accountant (CA) on their letter head as per the enclosed format (refer - **Appendix-2**) for the last three (3) consecutive financial years ending 31st March 2025 in support of the above and the same must contain Unique Document Identification Number (UDIN).

5. Warranty/Guarantee Period:

The supplied transformer shall be guaranteed for a minimum period of eighteen (18) months from the date of receipt of materials at site and completion of preliminary testing.

During the guarantee period, the Supplier shall, at no additional cost to the Employer, promptly rectify any defects or deficiencies arising from design, materials, workmanship, or installation. The Supplier shall remain wholly responsible for any corrective actions required under this defect liability obligation.

6. Price Basis: At Site SAIL-ISP Burnpur (FOR Basis)

7. To be submitted by the Bidders – PAN, GST Registration, Bank Mandate and Cancelled cheque.

8. Earned Money Deposit (EMD): EMD of Rs. 5 (five) Lakhs is to be submitted by the bidders. Scanned copy of the same shall be uploaded by Seller in the online bid and hard copy of the same will have to be submitted directly to the Buyer within 5 working days of bid opening, failing which the bid may be treated as incomplete & may lead to rejection of the bid by buyer without making any reference to the seller.

Bidders may be exempted from submission of EMD as per extant of the GeM Rule.

9. Performance Bank Guarantee (PBG) / Security Deposit (SD):

i. The successful supplier to submit performance bank guarantee of 5% of order value and valid for 18 months from receipt of materials at site and completion of preliminary testing.

ii. PBG/SD of 5% of Total Order Value must be submitted by Seller to the Buyer within 15 days of award of contract on GeM and it will be valid till warranty / Guarantee period. In case the seller delays submission of PBG/SD, a penalty of 0.2% of the original PBG/SD amount per completed day of delay, limited to an amount not exceeding 5% of the original PBG/SD amount shall be applicable. Payment for executed portion of order/contract should only commence on submission of requisite PBG/SD.

12. Appendix-1: The Appendix-1 (a combined undertaking), enclosed at Buyer uploaded ATC document, to be filled up and submitted by the bidder. Bidder to note that submission of Appendix-1 is mandatory; else their bid shall be liable for rejection (**refer - Appendix-1**).

13. Risk Purchase: Subject to the terms and conditions of this Agreement, if the Supplier neglects or fails to perform the Agreement by the time or times agreed upon, for any reason other than Force Majeure, the Purchaser after having come to know of such negligence or non-performance, after giving 14 to 30 days' notice or any such extended period that the Supplier and Purchaser may mutually agree, to the Supplier to rectify, shall take such action as it considers fit including but not limited to taking risk purchase action for supply of the material, mitigating any losses, at the risk and cost of the Supplier as far as the undelivered quantity in that Delivery Period is concerned. The Right of the Purchaser for Risk Purchase Action is in addition to the Right of Purchaser to terminate the Contract due to the fault of the Supplier. The price differential in case of higher cost to SAIL, if any, shall have to be borne by the defaulting Supplier. Moreover, the defaulting Supplier shall have no claim over the quantity, which they failed to supply.

14. General Terms and conditions: All other commercial terms and conditions shall be as per the latest version of GeM GTC. If, the GeM GTC is updated at the time of tendering, the same shall be applicable.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
