If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
5. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting

bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Experience Criteria:

The firm shall have experience in the field of maintenance related job of furnace or maintaining of FEDC system of furnace in Central Govt./PSU/State Govt./Public listed company/reputed private firm 30% of the estimated cost (i.e. Rs. 2.09 lakhs) within last five(05)years from the date of bid opening. The firm must submit copy of supply order, job completion certificate/performance certificate along with their offer. If required capacity verification based on the data furnished by the firm in the technical bid may be undertaken if considered necessary by the competent authority at MSF.

It is mandatory for all bidders to submit the past experience certificate, there will be no exemption/relaxation MSE and start ups

2.EMD 2%(Rs. 13,960.00)of the estimated cost however exemption is applicable in submission of Micro & Small Enterprises having Udyam Registration Certificate Number issued by department of Micro, Small & Medium Enterprises (MSME) or firms registered with Ordnance Factories/the Central Purchase Organization /the concerned ministry / Department / startup as recognized by Dept. of Industrial Policy & Promotion (DIPP) or Central PSUs.

3. **Option Claus:** The work completion period will be one year from the date of starting of work. if requirement is exist it may be extend up to three(03) months i.e 25% of the Supply Order value with same rate and same terms and condition of the Supply Order.

4. **Payment Terms:** Payment shall be made monthly basis (including applicable GST) based on the Job Completion certificate issued by the section.

5. Deployment of manpower: The firm shall deploy the sufficient number of experience manpower & supervisor to execute the work smoothly and time manner as directed by SIC/EIC/HOS. Depending on exigency of work firm shall deploy additional manpower in two shift i.e. morning/stagger shift which will be intimated by SMR section.

6. Working hours: Firm will deploy manpower in morning (8.00 a.m to 5.00p.m) shift excluding Sundays and holidays. However, in case of exigency of work with the necessary permission firm may have to work for extended period including stagger shift and Sundays/holidays.

7. Availability of office of service provider: An office of the service provider must be located in West Bengal. The address proof for this purpose will be considered as Registered certificate under West Bengal Shop & Establish ACT or as per GST Registration Certificate

8. Period of Contract: one year from the date of placement of Supply Order.

9. Minimum Manpower to be made available: It is advised that Minimum manpower to be deployed three(03)heads per day and they will work under the supervision of firm representative.

10.Records: The firm shall maintain record/register for deployment of Manpower. This will be verified and jointly signed by representative of SMR section & firm on Monthly basis.

11.Short Closed/Cancel: Executive Director reserves the right to cancel/short close the contract as and when required and for that no compensation will be given to the firm.

12. The personnel deputed shall be below 60 years old, good health and physically fit to work in hot, dust noisy, and smoky environment.

13. OPTIONAL SITE VISIT:

The Bidder is advised to visit and examine to obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder.

The Bidder representative shall be allowed entry upon consignee premises for such visits. Only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.

The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding. Working condition weather etc. On its own behalf.

14. Safety:

The personnel deputed shall wear PPEs such as Helment, Safety shoes, gloves, goggles for welding and grinding safety belt and hardness for working at height mask etc. Firm's offer will be inclusive of all safety equipment. MSF will not provide any safety equipment.

15 Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates/documents sought in the Bid document. ATC and Corrigendum if any.

16. Buyer Added Bid Specific ATC

Bidder shall carefully read the clauses mentioned in ATC & shall attach the compliance of the same duly signed and stamped. Mandate form to be submitted in prescribed format.

5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
