1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are

excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the

original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

3. **RATE QUOTATION:** Price shall be firm throughout the contract. Bidder is requested to quote rate inclusive of freight charges, GST, and testing charges (if any) etc.

4. Bidder(s) are requested to upload scanned copy of all the duly filled documents attached in ATC

5. Bidder(s) shall have to abide by the ruled and provisions contained in GCC-2022 available http://www.dvc.gov.in/dvcwebsite_new1/conditions-of-contract. (Also attached under Buyer Uploaded ATC document)

6. Bidder(s) have to upload documents as per GeM Bid document requirements. They are also required to submit documents as asked in "Buyer Uploaded ATC document" in bid document along with copy of GST registration certificate and PAN card.

7. Consignee and Delivery: Manager and Controller of Stores, DVC, Maithon.

The details of delivery of materials are as follows:

(a) Drawing to be submitted to indenter for acceptance within 15 days from date of issuance of Purchase Order ('Drawing' means 'Final Drawing' which needs no further correction/alteration. Date of submission of final drawing to be reckoned as the date of submission of drawing by the vendor).

(b) The materials are to be delivered within 120 days from the date of issuance of Purchase Order. Delivery period includes the time required for Manufacturing as per approved drawing, Routine Tests and successful completion of delivery of the whole lot of materials at DVC stores.

8. E-way bill will be issued on demand by the Consignee. On issuance of the Material Dispatch Clearance Certificate by the QC&I, Maithon, the vendor will directly contact the Consignee for issuance of E-way bill..

9. Payment Terms:

(i) 10% of the total basic value of the purchase order shall be paid as interest fee along with the purchase order of immediately after placing of the purchase order and submission of proforma invoice (PI).

(ii) Balance 90% payment along with full amount of GST and/or other taxes, duties, levies, cess, etc as applicable on the 100% basic value at the time of dispatch shall be paid against dispatch document and on submission of tax invoices through bank with a provision of part payment against part dispatch.

10. The bidder must submit **price reasonability certificate** (PRC) along with their offer stating that the quoted rates are reasonable and same as charged to other Govt. Organizations/ PSU etc. and in support of price reasonability, the order copies of similar items received from Govt. Organizations/ PSU are required to be furnished.

11. Transit Insurance: Transit Insurance from vendor's premises right up to DVC Stores will be arranged by DVC and name of the Insurance Company will be communicated to the successful bidder during issuance of purchase order. The successful bidder will intimate/ communicate with the ins

urance company before dispatch of the materials from its works/factory.

12. GUARANTEE & WARRANTY: The manufacturer shall warrant that all materials/equipments/items etc. supplied under the Purchase Order awarded shall be new, unused and confirm to the Purchaser's requirements and Technical Specifications. **The equipment supplied shall be guaranteed for 12 months from the date of commissioning or 18 months from the date of supply whichever is earlier.**

Within the Guarantee/Warranty Period if any material is found to be defective due to defective material / defective design / defective manufacturing process / poor raw material / bad workmanship, these shall be remedied free of cost by you. The guarantee period for such a replaced part shall be the same as that of materials specified earlier. The bidder shall submit the manufacturer's guarantee/warranty certificate along with the materials.

Inspection and acceptance of material, by DVC at DVC Site shall not in any way relieve the Vendor from the responsibility for proper performance during the guarantee period.

13. LD CLAUSE AND RISK PURCHASE CLAUSE :

In case of delay in delivery, for the reasons attributable to you, DVC reserves the right to recover from you, a sum equivalent to 0.5% of the value of the delayed materials for each week of delay and part thereof subject to maximum of 5% of the total value of the order as Liquidated Damage (LD).

Alternatively, the Purchaser reserves the right to purchase/ outsourced the material/spares/equipment/works /service from elsewhere at the sole risk and cost of the Vendor and recover all such extra cost incurred by the Purchaser in procuring the material/ works/ service by the above procedure.

Alternatively, the Purchaser may cancel the Order/contract completely or partly without prejudice to his right under the alternatives mentioned above.

In the event of recourse to alternative (ii) and (iii) above, the Purchaser will have the right to repurchase/ outsource the stores/works & service, to meet urgency in requirement caused by Vendor(s) failure to comply with the schedule of delivery/ completion of the work, irrespective of the fact whether the materials/ equipment/ works/ service is similar or not.

14. Basis of Freight: Inclusive in the quoted rate.

15. Drawing Approval:

(i) Within two weeks of the date of acceptance of P.O., a schedule of various routine tests to be carried out on raw materials and accessories etc. shall be submitted by the vendor for DVC's approval. No change in the schedule of tests shall be subsequently made by the vendor; its sub-contractors or the manufacturers without the prior consent of DVC.

(ii) Drawing complete in all respect and QAP is to be submitted to the Division Office, GOMD-IV, Putki for acceptance within 15 (fifteen) days from date of issuance of Purchase Order/LOI. Approval of final drawing will be given to the bidder by the Division office under GOMD - IV, Putki.

(iii) Approval of final drawing will be given by this office to the vendor within 7 (Seven) days from the date of receipt of the same. The vendor shall start manufacturing strictly according to the approved drawings.

(iv) After completion of manufacturing, Routine Test Reports of each item quoted for will be submitted to this office.

(v) After scrutiny of the test reports and satisfactory test results, dispatch clearance will be issued by Sr. Manager (QC&I), DVC, Maithon.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
