## क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें/Buyer Added Bid Specific Terms and Conditions

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Purchase Preference (State)

**Bid reserved for MSE from the State of Bid Inviting Authority:** Procurement under this bid is reserved for purchase from Micro and Small Enterprises from the State of Bid Inviting Authority having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

### 4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The Bidder must have average annual turnover of Rs 20 lakhs or above in last three financial years. The copies of Audited Annual Accounts/Statutory CA Certificate for last three years shall be uploaded along with the bid.

2. The bidder should be authorized by its OEM of products mentioned in the bid documents. Bid specific MA

F should be submitted by bidder.

3. The bidder must have one office in Madhya Pradesh. Please upload the copy of any of the following: Property tax bill/Electricity Bill/Telephone Bill/VAT/GST Registration/ Lease agreement

4. The bidder must submit an undertaking that they have not been black listed/ debarred by any state government / central government / PSU in last three years as on last date of bid submission. Undertaking on the 500rs. Stamp paper duly Notarized in favour of Department that the firm has never been blacklisted/banned (temporary or permanent) and disqualified by any state government / central government / PSU undertaking in India needs to be furnished.

5. The Bidder must submit their valid PAN, GST Registration Certificate.

6. The bidder should submit their ISO 9001:2015 Certificate.

7. The bidder's quoted rate of all items must be inclusive of all taxes and charges, No any other charge will be payable.

8. Bid is reserve for Bidders having Madhya Pradesh GST Certificate Only.

9. Delivery period for the products is strictly 15 days irrespective of what mentioned in bid document. If bidder fails to deliver the material in 15 days, order may be cancelled and Department is not liable to provide any clarification regarding the same. And EMD will be forfeited by Department. Bidder has to provide an affidavit on 500rs. stamp duly notarized regarding the same so that in future if order is cancelled due to non delivery of material in stipulated time, bidder cannot claim any legal procedures against the buyer Department.

10. EMD Submission is mandatory for every bidder and Hard copy of the EMD must be submitted in the department before bid end date.

11. For Experience criteria bidder or its OEM must have experience of 3 years for supply of same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year.

12. Bidder/OEM should have NSIC Certificate for Manufacturing of Fogging machine

13. The machine should be more than 95% made in India certificate from any Central Government Institute

14. The machine should have in built exhaust fan and manual off button in built in machine. Manual off system other than remote (Shut down can be done from remote and manually by machine too)

15. Bidder/OEM should have GMP Certificate , ISO 9001:2015 , ISO 14001:2015 and ISO 45001:2018

16. BIS Approved ISI Machine with Valid Operational BIS Certificate.

17. Petrol Tank in CRC Material only and Diesel Tank in SS Material only.

18. Carburetor based machine.

19. Test reports from BIS Approved LAB.

20. CERTIFICATE FOR RISK MANAGEMENT.

21. Auto cut off device compulsory

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and

resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
