1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

3. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. 4. **Turnover**

5. **Certificates**

6. **Certificates**

7. **Past Project Experience**

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. 12. 2- The product should be delivered and installed at the consignee specified location. Seller may get the same confirmed from consignee before scheduling delivery.

13. 3-In case of reseller, the bidder should submit bid specific Manufacturer authorization: Wherever authorized dealers are submitting the bid, it is necessary to submit the MAF along with the bid containing the OEM details like name, designation, address, e-mail ID and phone number etc.
14. 4-The Bidder/Seller must not have been blacklisted by any government or PSU entity in India for unethical practices. Confirmation requires an ATC as a Notary Affidavit on Rs. 100 non-judicial stamp paper, including the BID number
15. 5-The Bidder/OEM must upload ISO-9001:2015 (Quality management system), ISO- 45001:2018 (Health & safety management system), ISO-14001:2015 (Environmental Management system)
16. 6-Past Experience: The Bidder must have experience in successfully executed same orders of similar items. Copy of experience certificate to be enclosed as a proof of supplies.
17. 7- PAN Card. and Income tax return copy (with computation sheet) of last 3 years.
18. 8- Bidder Turnover Certificate duly certified with CA with a UDIN number.
19. 9- Zed certificate, MSME certificate.
20. 10- Bidder must be provided by Original Equipment Manufacturer (OEM) Certificate and OEM Turnover should be uploaded with bid.
21. 11- EMD exemption is not allowed (Reseller/OEM/ MSME/ NSIC/Vendor)
22. 12- EMD must be submit in FDR form duly Pleaded to E O Nagar Palika Parishad Afzalgarh Bijnor.
23. 13- Bidder must submit to all documents self Attached .
24. 14- All ATC Accept Documents must be uploaded.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
