OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**2. Buyer Added Bid Specific ATC**

  - a. No other order copy of different item will be accepted as per performance and experience.
  - b. Compliance of specifications should be matched point wise.

  - d. The authority letter uploaded by the bidder should be valid and authentic.
  - e. After Technical Evaluation Demonstration may be asked if required.
  - f. If any bidder/participant will upload any document which is found irrelevant against the requirement the authority has the right to reject the bid outrightly.
  - g. All the equipment should be offered with 3 years warranty.
  - h. The installation site will be confirmed once the supply order will be placed to L1 bidder.
  - i. Average annual Turn over of latest 3 years should not be lower than 2 crore.

- j. EMD can be accepted by the authority in the form of a bank guarantee from any nationalized bank, submitted by the participants against the tender.
- k. The Bidder shall submit and undertaking on affidavit to ensure that all documents, certificates, information, and data submitted as part of this tender are correct, authentic, genuine, and verifiable. Any submission of false, fabricated, or misleading information shall result in immediate disqualification of the bid and may lead to legal action and blacklisting of the Bidder.
- l. The Bidder hereby declares and warrants on affidavit that the Bidder, including its proprietor/partners/directors, has not been blacklisted, debarred, suspended, or declared ineligible by any Central Government, State Government, Public Sector Undertaking, Government Department, Government Agency, Local Body, or any Private Institution/Organization in India or abroad. b) No investigation, inquiry, or legal proceedings are pending against the Bidder for any malpractice, fraud, or unethical business conduct. c) The Bidder has not been convicted of any criminal offense related to business operations or professional misconduct.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
