1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. ### 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 3. **Generic**

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

#### **Scope of Supply:**

**Complete supply in this tender includes: 04 number of Upper Grinding Ring, 04 Number of Lower Grinding Ring, 40 number of Grinding Balls, 01 Teak Wood pattern of Upper Grinding Ring, 01 Teak Wood pattern of Lower Grinding Ring and 01 Teak Wood pattern of Grinding ball as per the Approved Specification, Drawings and Quality Plan. Above mentioned Wooden pattern, which have been used in casting of grinding elements, will be part of supply. The patterns shall be the property of NSPCL and the same shall be supplied along with the delivery of last set of grinding Elements. The scope of transportation, packaging and transit insurance of the patterns shall be same as of the grinding elements.**

#### **Terms and Conditions:**

##### 1. Inspection:

a. Pre-Dispatch Inspection (PDI) of Grinding Elements and Wooden Patterns shall be carried out at vendor works as per approved Drawings & QAP Ref no: NSPCL/DGP/FQA/Grinding Ball, Ref no: NSPCL/DGP/FQA/Grinding Ring, DRG NO. A1/308.02.54/43021B, A1/308.02.54/43020C and NSPCL/Wood Pattern/ 2025/ QP-03.

b. Reference Drawings: Enclosed Drawing DRG NO. A1/308.02.54/43021 B & A1/308.02.54/43020 C are to be referred by the bidders/vendors. For Wooden pattern, vendor has to develop drawing and get it approved

ed from NSPCL.

c. Final Inspection will be done by NSPCL Inspecting Official preferably within 7 days on intimation for inspection by the vendor.

d. PMI by XRF analyser will also be done by NSPCL after material receipt at NSPCL Durgapur store for Grinding elements only.

## 2. Guarantee/ Warranty:

a. The Minimum Guaranteed life for the complete Pulverising/ Grinding element set shall be 4500 running hours or higher quoted guaranteed running hours by the agency.

Detailed Guarantee Clause shall be as per Annexure- B.

b. For NSPCL Durgapur One Set of Pulverising/ Grinding Elements consists of "1 no. of Top/Upper grinding ring + 1 no. of Bottom/ Lower grinding ring (both as M4596020136) and 10 no. of Grinding balls (as M4596020134)".

c. Guarantee Clause of Annexure- B is not applicable for Wooden Patterns for Guaranteed Life evaluation and retention of PBG.

d. For Used Wooden pattern, Vendor shall provide a Guarantee/ warranty of 12 months from supply against poor workmanship.

e. Actual running hours shall be logged in NSPCL Durgapur Records.

f. Wear limit/Exhaustion limit of the elements shall be as per Annexure: "G".

3. PERFORMANCE GUARANTEE: The vendor has to submit a performance bank guarantee of 5% of the total PO value towards performance guarantee for a period of 24 months. Performance Guarantee clauses shall be as per Annexure: "E" and will be applicable on total PO value. However, retention of PBG is not applicable for Wooden pattern.

4. Documents for Bid Evaluation: Vendors are requested to submit Techno-commercial offer along with endorsed tender documents, Quality Plans, Drawings and Annexure- B, D, E, F and G as token of their acceptance. Bidders have to declare their offered minimum Guaranteed life for the complete Pulverising/ Grinding element set as per Annexure-B.

If the bidder doesn't declare their offered Guaranteed Life then it will be taken as 4500 running hours/ set

5. Documents Required with supply: Material TC, GC/WC, MDCC, CHP inspection reports to be submitted along with delivery.

6. Bid evaluation for L1: Comparison of bids shall be made on the basis of the landed cost per running hour per complete set of Pulverising/ Grinding elements along with wooden pattern. Details of "Evaluation criteria for the tender" is enclosed at Annexure: "F". Bid will not be considered for evaluation if quoted guaranteed running hours is less than 4500 hours for any of the Grinding Elements individually or as a set, as listed in BOQ.

7. Award: Award of Contract shall be done on a single package basis only with Bid evaluation as described in Clause 6.

## 8. Delivery Schedule:

a. First set to be delivered within 09 months from the date of award.

b. For next 03 sets, delivery schedule shall be at least one set in each 45 days starting from the 9th month

c. Entire delivery has to be completed within 13.5 months from the date of award and material has to be delivered at NSPCL Durgapur.

## 9. Drawing and Quality Plan Approval:

a. Approved Quality Plan for Grinding Elements and Wooden patterns are part of tender.

b. If the bidder changes the material specification as mentioned in Annexure-D, then bidder shall submit the detail drawings mentioning weight of each ring and ball and quality plan in line to the approved "QAP" along with the offer submission.

c. Successful Bidder shall develop pattern drawing and get this approved post award. However, this approval for pattern is for Inspection purpose. Casting outcome and tolerances are the sole responsibility of Agency only.

#### 10. Payment Terms:

10 a) 90% Payment shall be done as per the invoice raised for each set supply, subject to receipt and acceptance at NSPCL site store .

10 b) 5% Payment shall be held on account of the submission of the PBG against the complete PO. The same shall be released after the receipt/ acceptance of PBG at NSPCL. If PBG is not submitted, the PBG value will be held from the payment.

10 c) 5% Payment of each invoice will be held in lieu of Wooden Patterns. This 5% held from each invoice shall be released on receipt and acceptance of last set along with Wooden Patterns .

#### 11. Additional Information:

a. Any clarification may be sought before Bid opening. Post Bid opening, no deviation shall be accepted.

b. During transportation, Wooden patterns must be packed in steel crate with proper cushioning. Steel Crate may be considered as a covered Box made of MS sheet of 22 Gauge or thicker with stiffeners and supports.

c. In case the patterns get damage during the casting process at vendor's works or during transportation, the same shall be rectified/ replaced free of cost, no additional charges shall be paid. In case of any dispute regarding rectification or replacement of damaged patterns, the decision of NSPCL shall be deemed final.

d. Material specification for Top/Upper & Bottom Rings shall be NI HARD-IV and that of Grinding & Filler ball shall be CrNi-108(chrome nickel-108) as per Annexure-"D".

However, the bidders are permitted to supply suitable higher-grade material for complying/exceeding the minimum guaranteed life without compromising the guarantee clause.

The agency shall be allowed to collect the available coal analysis data and may collect samples of coal for analysis at their end before quoting.

i. Grinding Ball Size: OD 750 mm. (+5, -0) and ID 560 mm.

16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.**

**For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.**

**The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:**

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
