1. Buyer Added Bid Specific ATC

Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including add-ons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

Buyer Added text based ATC clauses

1. Generic

After award of contract - Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing- the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Scope of Supply

Scope of Supply (Bid price to include all cost components): Supply of goods with complete on-site support.

4. Mandatory Certificates:

To be eligible for the award of the contract, the bidder must possess a Character Certificate and a Solvency Certificate duly issued by the District Magistrate. The same are enclosed herewith for your kind perusal and necessary action. These certificates have been obtained from the competent authority and are valid as per the prescribed norms.

5. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 6. Service & Support

7. Forms of EMD and PBG

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C **Deputy Director DUDHWA TIGER RESERVE, PALIA KHERI** The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

8. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

9. Certificates

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

10. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

11. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

12. All the bid documents along with the emd of two percent in mention bid, submission is compulsory for all the bidders, no exemption to any MSME/Startups) uploaded while participating in the bid shall be physically

submitted to the buyer office within 5 days of Bid End date/ Bid Opening date

13. The bidder shall submit self-attested copies of PAN Card, GST Registration Certificate along with the latest GST Return, Aadhaar Card, and T-6 certificate as per PWD rules, along with the bid documents.

14. Successful bidder has to get advance approval of the sample or diagram from the office, before final supply of items.

15. The construction work must be completed by 31-03-2026 from the date of issue of the work order.

16. Payment will be made only when the quality of the material supplied as per the work order is as per the standards of the department.

17. If for any reason the dates mentioned in the tender notice happen to be a holiday, the tender will be opened on the next working day.

18. As per above, the material has been estimated in relation to the physical target allotted to the division, the quantity of material may increase or decrease depending on the budget availability, for which no claim of the bidder will be accepted.

19. It will be mandatory for the bidder to upload specifications and sample of the material and diagrams.

20. If the firm/company is a partnership then it will be mandatory for all the individuals to upload Aadhaar Card

, PAN Card and Partnership Deed.

21. The undersigned reserves the right to reject any or all the bids without assigning any reason.

22. The participating reseller company Documents will be verified by the buyer and if find illegal, bidder will be blacklisted or legal action will be taken against the firm/company. And it is mandatory to upload a declaration of non-blacklisting, criminal and not being registered with the Bar Council State Government and Government of India on Rs. 100/-non-judicial stamp with notarized attestation. bid effective date. and the bidder has to delivery of hardcopy to the buyer within 5 days of bid end date / bid opening date.

23. It will be mandatory for the company/firm/individual firm to attach the certificate to give the name of the firm,

Current Place of the office, mobile Number and account Holder bank Details.

24. Supply Experience - The bidder should have experience in supplying. In respect of supply of any one order within the last five financial years. Which is 80% of the estimated cost of the bid.

25. To be eligible for award of contract, bidder must possess following certificates uploaded with bid document Quality Management System Certificate, Environmental management systems Certificate and MSME

registration.

26. the bidder shall have to confirmed that bid over all conditions are acceptance must be uploaded on Letter

head and the bidder has to delivery of hardcopy to the buyer within 5 days of bid end date / bid opening date.

27. To be eligible for award of contract, bidder must possess following certificates uploaded with bid document, latest Balance sheet and ITR Return.

28. Queries or objections may be submitted only within the bid period and the prescribed time limit. Any complaint received after the closure of the bid or at the time of bid opening shall not be considered.

***Note*- If the bidder does not upload any documents or unreadable or unclear scanned, then he will be disqualified.**

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
