The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. **1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the origin delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**2. Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Participating bidders should have a minimum of 2-3 service centres in Karnataka (Mainly at Mangalore/Udupi) documentary proof of the same must be submitted along with the bid. Bidders failing to submit such proof shall be disqualified.
2. The FRRC dimensions and specifications shall strictly conform to the relevant Indian Standards (IS).
3. The Original Equipment Manufacturer (OEM) should have a minimum of 5 years' experience as on 31.12.2023 the activity of supply of TRTL safes.
4. The OEM must submit audited financial statements for the last three financial years, i.e., 2022-2023, 2023-24 and 2024-2025.
5. The BIS labelling should clearly indicate the manufacturer/brand name, class and rating of the product, year of manufacture, IS number, and CML number allotted by BIS. The product must have 120 minutes fire resistance.
6. The vendor should have OEM authorization for locks and IS 17566 certification is mandatory.
7. Only authorized dealers of Original Equipment Manufacturers (OEM) are eligible to participate. An authorization letter issued on the OEM's letterhead must be enclosed with the bid.
8. The OEM shall possess a valid BIS license for all the physical security equipment mentioned in the tender. If the BIS license for any 5/8 category product expires before completion of the tender process, the renewed license must be submitted to the Bank, failing which the bidder will be declared ineligible.
9. The OEM and/or Authorized Agent shall provide written consent to the Bank for random testing of the supplied products at their cost at any BIS-approved laboratory. The product selected for testing shall be replaced with a new product of the same class prior to testing, free of cost. The OEM/Authorized Agent shall bear the transportation cost from the branch to the testing venue and the testing charges payable to the testing agency. This requirement shall be exercised at the sole discretion of the Bank, as and when required.
10. Experience with PSU Banks/Scheduled Commercial Banks only shall be considered. Copies of purchase orders along with contact details of the purchaser must be attached with the bid for verification.
11. The vendor must submit valid ISO certification.
12. The OEM should not have been blacklisted/debarred in the last three years (as on the date of bid submission) by any Government Department, Financial Institution, Public Sector Unit, or Scheduled Commercial Bank in India. A declaration to this effect must be submitted on the OEM's letterhead.
