1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

#### (I) Eligibility Criteria:

Bidder should meet the following criteria.

**A.** Only indigenous manufacturers, their authorized dealers, or Indian suppliers are eligible to quote. The tenderer shall submit an ISO certificate/ certificate from any government/government-authorized agency to demonstrate that their OEMs/ bidder are manufacturers of the tooth points and lock pin or similar category of items.

#### **B.**

(i) The indigenous tenderer must submit copies of purchase orders and GST invoices as proof of supplying a minimum of 24 nos. tooth points and 12 nos. lock pins for a machine with a

minimum bucket capacity of 9.5 cubic meters or higher, successfully completed for any of the following organizations within the last seven (07) years from the bid invitation date:

- Public Sector Undertaking
  - Government Organizations
  - Public Limited Company
  - Joint Venture Company, where at least one partner is a government organization or PSU.
- (ii) To support the successful completion of the purchase orders mentioned in paragraph **B(1)**, tenderers must submit a performance certificate from the purchaser (OR) submit a self-attested declaration stating that the items supplied against the above purchase orders have no adverse reports as of the bid submission date and that these orders are regular, not trial orders.
- (iii) If the supply is completed indirectly, the tenderer must provide relevant documents to establish that the end user of the items supplied under the above purchase order belongs to one of the four types of organizations mentioned above.

- C.** To assess financial capability, the tenderer shall submit audited annual balance sheet for any consecutive three of last four years from the bid invitation date and the timing turn over value shall be mentioned in the indent by the indenter as per details mentioned below. The average annual turnover of the firm for any consecutive three of last four years shall be equal to or more than the Rs 07 lakhs.

Case-I

Turn over value is in increasing trend then average of the two turn over values must be equal to or more than the Rs.07 lakhs.

Case-II

Turn over value is in decreasing trend then lower of the two turn over values must be equal to or more than the Rs.07 lakhs.

50% of the Turn Over value must be equal to or more than the Rs.07 lakhs.

**(II) Special Terms & Conditions:**

1. **The supplied materials should have a guarantee** for minimum 450 working hours from the date of fitment in the excavator. If any defect arises during the guarantee period the party has to replace the items free of cost. The cost of replacement viz transportation etc. shall be borne and arranged by the supplier.
2. **The Supplied Tooth point and lock pin shall be such that there should no issue/defect in one to one fitment in 9.5 cum excavator (suitable for Komatsu make PC 2000-8 excavator). For any issue/defect, the supplied material will be rejected out rightly.**
3. **The Supplier shall provide a performance certificate for fitment of Tooth points and Lock pins for 9.5 cum excavator from organizations as mentioned in Eligibility Criteria Para B.(1) .**
4. As per the requirements of SAIL-KIOM, the ordered quantity of tooth points and lock pins may be

e subject to a variation of +25% within a period of 01 (one) year from the date of issue the purchase order. The decision to operate within this range will be at the discretion of SAIL-KIOM.

5. Items should be procured on a single source and single party basis.

6. **Phase Delivery:**

(a) 66 nos. tooth points and 36 nos. lock pins must be supplied within 30 (thirty) days after the issue of the

Purchase order.

(b) Balance 66 nos. tooth points and 30 nos. lock pins must be supplied after three (3) months after the first

Phase of delivery and before 4 months of the issuance of the purchase order.

**(III) RISK PURCHASE CLAUSE:**

Subject to the Terms and Conditions of the GEM contract ,if the Seller/ Supplier neglects or fails to perform the contract by the time or times agreed upon, for any reason other than Force Majeure, the Buyer/Purchaser after having come to know of such negligence or non-performance, after giving 15 days notice to the Seller/Supplier or any such extended period that the Seller/Supplier and Buyer/Purchaser may mutually agree, to the Seller/Supplier to rectify , shall take such action as it considers fit including but not limited to taking risk purchase for supply of the material, mitigating any losses , at the risk and cost of the Seller as far as the undelivered quantity in that Delivery Period is concerned. The Right of the Buyer for Risk Purchaser Action is in addition to the Right of Buyer to terminate the Contract due to the fault of the Seller/Supplier.

The price differential in case of higher costs to SAIL, BSL ,KIOM/MIOM if any, shall have to be borne by the defaulting Seller/Supplier. SAIL ,BSL ,KIOM/MIOM reserves

the right to recover the price differential from pending bills of the supplier in BSL or other units of SAIL. Moreover the defaulting Seller/Supplier have no claim over the quantity, which they failed to supply.

**(IV) Guideline on Verification of Credentials submitted by Bidders during Tender Evaluation:**

i) SAIL reserves the right to verify any supporting document(s) submitted by a participating tenderer / bidder from its source (document issuing authority).

ii) In the interest of expeditious completion of verification, a participating tenderer /bidder shall provide a list of each supporting document on its letter-head as per "Annexure-S", along with the contact details (postal address, email address, landline / mobile number) of the issuing authority of each supporting document for verification.

iii) Non-verification of any supporting document or information, at the sole discretion of SAIL, does not absolve the tenderer / bidder of its absolute responsibility to provide only genuine document(s) in support of eligibility conditions.

iv) In case a supporting document or information is found to be fake/forged/tampered/ non-genuine at any stage during tendering process & even after placement of Purchase Order / Work Order, the tenderer/bidder is liable for punitive actions as per extant guidelines of SAIL.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

**The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:**

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
