If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. ### **1. Scope of Work**

**(a) The scope under this bid is restricted to supply and delivery only of Half Cut RCC Hume Pipes (NP-3 Class), complete in all respects, within the Area of Responsibility of Road-89 RCC, BZ NRB Road.**

**(b) The quoted price shall be all-inclusive towards manufacture (where applicable), supply, transportation, loading, unloading, tools & plants, manpower, equipment and all incidental activities directly related to supply and delivery only.**

### **2. Delivery Location**

(a) Concrete shall conform to the approved grade specified for NP-3 class pipes as per IS 458.

(b) Reinforcement steel shall conform to IS 1786 / IS 432, wherever applicable.

(c) Dimensional tolerances and curing shall be as prescribed under IS 458.

---

### **5. Testing & Quality Assurance Requirements**

(a) Pre-Dispatch Inspection (PDI) is NOT required.

(b) The bidder shall submit test reports issued by a NABL-accredited laboratory only.

(c) Pipes shall be tested strictly in accordance with IS 3397 for the following tests:

- Hydrostatic Test
- Three Edge Bearing Test
- Permeability Test

(d) Testing frequency shall be as per Clause 11 of IS 458:

**(e) Submission of valid NABL-accredited laboratory test reports conforming to IS 3397 and IS 458 (NP-3 Class) is mandatory and a condition precedent for acceptance of stores.**

**(b) If OEM status or OEM authorisation is claimed, a valid notarised OEM certificate shall be submitted.**

**(c) Non-notarised OEM documents shall render the bid non-responsive.**

## **9. Payment Terms**

**(a) Payment shall be released only after successful supply and delivery of the Half Cut RCC Hume Pipes.**

**(b) Payment shall be subject to submission of a delivery certificate duly certified by the Officer-in-Charge / Officer Commanding, Road-89 RCC.**

**(c) No advance or part payment shall be admissible.**
