OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. ### 3. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

### 4. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 5. **Buyer Added Bid Specific ATC**

1. The duration of the contract is initially for a period of 02 year and further extendable for 01 more year on the basis of the satisfactory performance of the firm but the overall contract duration cannot exceed 03 years.

2. The selection of the candidate has been done by the departmental selection/screening committee on the basis of the required skill test/interview.

3. In order to avoid fraudulent practices, the bidders must quote minimum service charge greater than or equal to 3.85% in GEM. Any vendor submitting vendor service charges less than 3.85% will be disqualified and summarily rejected without considering the technical parameter.

4. If it comes into the notice of the department that L1 Selected firm may charge some amount of Fees as placement charges from the selected candidate then the contract of the L1 firm has been cancelled and the firm has been blacklisted by the department.

5. The bidder must belong to the state of consignee and in this regard documentary evidence should be submitted.

6. The buyer may reduce or increase the quantity of required manpower by 25% at any time during the running of contract period.

7. The Contractor must also ensure that all hired staff is not facing any criminal prosecution and are of good character. If any time any such status is found on any manpower so hired, it will be subject to replacement. In case the contractor denied to replace the manpower then the penalty may be imposed on the contractor as per GEM GTC.

8. Here in case of work experience, the term similar nature of work means, the firm should provide the DE Os, Stenographer and Driver related manpower to any of the Central/State Government/ PSUs/ Nationalised Banks/ Reputed Organisations. In this regard, the bidder must submit copy of work order along with completion as per GEM clause mentioned in the bid document.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
