A. Bidder to note that this bid shall be governed by the terms and conditions of the Bidding Document uploaded under Specification Document. This uploaded instructions/ Terms & Conditions/ Technical specification of the Bidding Document shall supersede the provisions of GeM GTC and any of her disclaimers provided in GeM Bid.

B. In case a bidder does not register on the GeM Portal and as a consequence, does not submit the bid on GeM Portal, it shall be deemed that he is not interested in bidding against this enquiry and no further correspondence will be entertained.

C. Wherever e-tendering portal or NIC or CPP Portal has been mentioned in the commercial section , the same shall be read as GeM Portal.

D. Bidder shall quote their Prices on FOT Site basis (i.e., including Freight up to Project Site) including all taxes and duties including GST.
