1) ALL THE DOCUMENTS UPLOADED SHOULD BE ON THE BIDDER'S LETTERHEAD. DOCUMENTS CLEARLY SPECIFYING THE ACCEPTANCE OF ALL THE TECHNICAL SPECIFICATIONS, ADDITIONAL SPECIFICATION PARAMETERS AND TERMS & CONDITIONS SHOULD BE UPLOADED.

2) "Vehicles with GPS facility will not be allowed entry inside purchaser's premises. In view of the above, the consignments should be dispatched only through vehicles without GPS system."

3) The ordered items shall be supplied to the respective stores only on working days and between 10.00 hours to 16.00 hours excluding Saturdays, Sundays and Public Holidays. The supplier shall give advance information in the consignee through email before delivering the material.
