## 12. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Two Blocks of the Guest House Approx. 1450 Sq. Ft. of area (excluding two bedrooms used as a reserved for institute use) are allotted for setting up of the Kitten Area and related work for running of Guest House. The license fee for this space is set to Rs. 14,500/- (Rupees Fourteen Thousand Five Hundred) plus applicable taxes which has to be paid by the service provider to the Institute on monthly basis.

2. In addition to license fee, the Electricity Charges are as per actual and the fix amount of Water Charges of Rs. 1000/- for the utilization of the kitchen are shall be payable by the Licensee / service provider to the Institute per month and the proof of payment of charges and taxes shall be submitted to the IITN Admin office.

3. As per the GeM policy the Bid is being floated for One Year duration. It can be extended for the further period at the sole discretion of the institute upto the maximum period of 2 Years on yearly basis on the same terms, conditions & price. (The duration of the Contract referred here in above shall be maximum of Three (3) Years subject to satisfactory performance and renewal on year wise basis.).

4. The contract shall be awarded on the basis of the L1 rate quoted in Table [A]. However, the L1 bidder shall be required to match the lowest rates quoted in Table [B] by any of the technically qualified bidders.

5. It is compulsory for all bidders to provide the Table B Charges as part of their financial bid. Bids submitted without duly filled Table B Charges shall be treated as non-responsive and shall be summarily rejected without any further correspondence. Bidders are therefore advised to ensure that all financial tables, including Table (B), are properly filled, signed, and submitted as per the bid terms and conditions.

**6. In the event of the Selected Bidder fails to complete a minimum contract period of one (1) year for any reason attributable to the Bidder, the entire Security Deposit shall be forfeited, and no claim whatsoever in respect of the Security Deposit shall be entertained by the Institute.**

**7. In the event that multiple bidders are identified as the Lowest (L1) bidders after financial evaluation, the selection of the successful bidder will be conducted through the 'Run L1 Selection' feature provided by the Government e-Marketplace (GeM) platform or as per the GeM policies revised from time to time.**
