1. **Buyer Added Bid Specific ATC**

Terms and Conditions for hiring of the taxi service

1. One Commercial Vehicle namely Mahindra Balero or Scorpio should be engaged during the enforcement of agreement.
2. The agency is required to provide the Vehicle along with the Driver only (purchase of fuel will be solely dealt by the Tea Board Zonal office at Coonoor)
3. Vehicle on hire must have proper valid permits/ licenses/ registration etc. from the appropriate Govt. authorities.
4. The age of the vehicle must be between 02 to 07 years or within 40, 000 Kms limit.
5. The Engagement time of the vehicle will be from 9.00 AM to 7.00 PM. Engagement of the vehicle beyond the regular working hours will be paid in proportion to the applicable Hourly charges against the Monthly remuneration.
6. Monthly kilometre limit will be 2500 kms (overall).
7. The vehicle on hire may be required to ply continuously during the day time and occasionally in the night hours.
8. The hired vehicle should have 'All India Permit' and will have to perform official tours all over South India and outer states as per the requirement and directives from the Competent Authority.
9. The Fastag and other related requirements must be kept ready for usage
10. The cost of maintenance and other related expenses of incidental cost a

and all expenses of the driver are to be borne by the agency and the driver should keep the vehicle in neat and clean condition always roadworthy.

11. The agency must be in a position to provide/ supply the vehicle for hiring immediately from the date of issue of work order.
12. In case the vehicle/ Driver on hire goes out of order, the agency must provide/ supply another alternative good condition vehicle/Driver immediately without delay and without any extra charges.
13. In case of an accident / traffic violations the agency will be solely responsible for all follow up remedies including legal proceedings/ Exps. If any and the Tea board will not bear any cost/responsibility in any way for the men and materials. The Agency will compensate the damages for all the materials and or their parties fully without involving Tea Board and indemnify Tea Board against loss/damages occurring while the vehicle is under use. The vehicle must be insured as per the Govt. norms.
14. Proper uniform, courtesy and good behaviour from the part of driver is essential. The payment will be deducted as deemed fit by the CA if in case, any deficiency is found in the uniform, courtesy and good behaviour.
15. While on duty the driver should keep all the essential documents such as the valid license, Insurance and Tax documents for
16. The driver should maintain a proper log book/ Duty Slip for recording of daily kms & hours utilized as per the proforma provided by the ZO- Coonoor. At the end of every month the driver is liable to produce the same for verification to the ADTD(Estt.)/ DDTD.
17. The Tea Board is empowered to return the vehicle if it is not road worthy and no payment will be made for the said journey.
18. The Agency is solely responsible for the payment due to accidents which directly attributes to driver's negligence or any unforeseen happenings and the Tea Board is not at all responsible on this account.
19. It is the responsibility of the Agency to get the journey trip verified with the entries in the log book / duty slip each day.

20. In case the vehicle is withdrawn for maintenance and repairs, substitute vehicle in good condition should be provided immediately by the agency.
  21. In case, the agency fails to provide the vehicle on a particular day/time, the pro- rata amt. shall be deducted from the monthly bill and in addition penalty of ₹500/- (₹Five Hundred only) will be deducted as deemed fit by the CA.
  22. The agency shall be bound to follow the rates quoted mutually and agreed upon and shall not ask for any enhancement of the rates for providing of vehicles during the period of agreement.
  23. The agreement is subject to terminate any time by both the Board and the agency by giving a notice of 07 days in writing. If the condition of the vehicle is not roadworthy or any of the stipulated conditions of the Contract are not adhered to.
  24. It will be the sole responsibility of the Agency to ensure proper maintenance of vehicle in Good condition with follow up of valid RTO norms. The Board shall not in any way be made liable/ responsible for any act(s) of omission that the agency may commit and consequences thereof.
  25. The agency shall submit the bill in duplicate to the Tea Board, ZO- Coonoor for payment with an advanced stamped receipt (pre receipted) on the 01<sup>st</sup> day of the subsequent month.
  26. The Executive Director, Tea Board India, Zonal Office Coonoor reserves the right to terminate the agreement at any time without mentioning any reason thereof.

Mode of payment: The monthly bill would be submitted by the agency to the Deputy Director, ZO- Coonoor for payment on the first day of the following month by RTGS/ NEFT.

Commencement of Agreement: The agreement shall come into force w.e.f. \_\_\_\_\_ for an initial period of 01 year which may extend further with mutual consent. However, due to unavoidable circumstances, if the parties are not able to agree mutually for extension of the contract period, the agency shall continue to render services till any alternative arrangement is made with the existing terms and condition for a period of max. 03 months.

Premature termination of the agreement:

The either party is entitled to terminate this agreement due to some unavoidable circumstances by giving a minimum notice period of 07 days in w

riting in lieu of One month's payment.

### Income tax

If it brought into the notice of the Tea Board by the appropriate authority about default of payment of statutory dues, the same shall be deducted from the monthly payment of the agency and shall be deposited before the appropriate authority in order to utilize the uninterrupted services.
