1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and

for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Buyer Added Bid Specific ATC

Additional Terms and conditions:

1. Delivery: The supplier must ensure the delivery of all items at the specified within 30 days from the date of issue of the purchase order.
2. Warranty: A minimum 2-year warranty must be provided for all items. Warranty service must include the repair or replacement of the defective items.
3. Compliance and Certification: **All items must comply with relevant safety and quality standards (ISI) Certification .The digital catalogue must be uploaded against each item with details specifications. The supplier (L1) must produce sample before the final delivery of the materials, after approval from the competent authority only the full materials will be delivered.**

4. Inspection and Acceptance: All items will be subject to inspection upon delivery. Items failing to meet the specified standards or damaged and brakeage will be rejected and must be replaced at once with no additional cost.
5. Penalty Clause: Any delay in delivery will attract a penalty of 0.5% of the total order value per week, up to a maximum of 5%.
6. Customer Services: The supplier must provide contact details for customer support and warranty claims.
7. Local Office Requirement: **Availability of office in the State of consignee during the last 1 years.** Documentary evidence required for this Bid.
8. Successfully approved Bidder after approval from the Buyer will start bulk supply. Any expenses incurred by the bidder for placing of sample shall be borne by the seller and shall not claim any compensation in the event of such sample being found unacceptable by the buyer. In case the sample is found to have major deviations from the contract specifications or not conforming to the contract specifications, the buyer at his discretion may call for fresh samples for approval, before allowing bulk supplies, or may terminate the contract.
- 9. Tender inviting authority reserves the right to reject or cancel any or all pre-qualification documents or bid documents without assigning any reason whatsoever.**
10. No conditional/ incomplete tender will be accepted under any circumstances.
11. The bidder must have positive net worth ending 31st March of last three financial years.
12. Specific OEM Authorization /MAF Certificate required.
13. Bidder must have valid ISO 9001: 2015 certification.
14. The bidder Firm/Owner/Director/Partner should not have any criminal background/ insolvency/liquidation occurrence in the past. The Bidder firm should not have been ever suspended OR debarred OR Blacklisted from any Central/State Government Department in the past.
15. Self declaration has to be submitted by the bidder confirming not having supplied any substandard material in the past to any Central/State Government Department and no deduction from any Central/State Government Department on such account has been ever made in the past. The committee will decide for the qualification of bidder on the basis and this condition will not mean for the automatic rejection of the bid.
16. Data Sheet of each product(s) offered in the bid, are to be submitted along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection. Any deviation on product specification will not be considered.
17. The bidder must have valid GST for the state of West Bengal. Bidder must submit GST Certificate.
18. The Bidder must submit copy of PAN, Professional Tax (FY 2024-25), Trade License.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
