1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 2. 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old,

the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

10. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

**OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**Testing of Sample:** The testing of advance sample and bulk sample during PDI will be carried at the designated AHSP labs. When testing facilities are not available, the facilities of Govt labs/NABL/Accredited labs will be utilized. The testing charges outside the designated AHSP labs to be borne by seller's.

#### 10. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

**Short closure of ARC** In case of full contract quantity utilized before completion of contract period or due to poor/short supply view unjustified reason, CFA retains the right of short closure during tendering/ contract period for any item mentioned without notice.

**Extension of contract** In case of non-conclusion of new contract due to some special reason, the contract operating authority can initiate extension of the existing contract for a period generally not be more than three months with same terms and conditions etc, with the consent of the rate contract holder. Existing contractors which do not agree to such extensions, can be left out for consideration for renewal of the contract. Willingness of the firm is not be mandatory for invoking option clause and for invoking any other terms and conditions of contract.

**Risk & Expense Purchase Clause** Risk and expense purchase is undertaken by the purchaser in the event of the supplier failing to honour the contracted obligations within the stipulated period and where extension of delivery period is not approved. While initiating risk and expense at the cost and expense of the supplier, the purchaser must satisfy himself that the supplier has failed to deliver and has been given adequate and proper notice to discharge his obligations. Whenever risk purchase is resorted to, the supplier is liable to pay the additional amount spent by the government if any, in procuring the said contracted goods/services through a fresh contract i.e. the defaulting supplier has to bear the excess cost incurred as compared with the amount contracted with him. Factors like method of recovering such amount should also be considered while taking a decision to invoke the provision for risk purchase.

**Signing of contract agreement (Acceptance of Tender)** The successful bidder/ contractor will be required to sign an agreement with the contract operating authority within 30 days from the date of award of contract. Provisioning of e-stamp paper and other requisite action as required are to be done by the contractor at his/her own expense.

Format of AOT will be given by this office on award of contract that will have to be re-submitted within 30 days with the proprietor's signature and firm's round stamp to this office which will act as agreement within 30 days of the payment will be stopped. Risk and expense may be done using PBG/ payments of other running contracts with Indian Navy. If the firm fails to submit contract agreement and PBG within 30 days of award on even after reminder letters issued by this office, CFA holds all the rights to terminate the contract without any prior notice and justification.

**Supply of the Items** The items are to be supplied to BVY (Koc) as per demand in staggered delivery as per purchase orders raised by the BVO (Koc). Moreover, all operational requirements of the Command are to be met by the vendor within 15 days as per the purchase order raised by the concerned units.

**Lab test** Vendor has to bear lab test charges for random sampling carried out during supply period. Lab test of the tender sample will be carried out by the buyer and the payment to be made by the bidder. An undertaking to pay the lab testing charges within 07 days of intimation to be submitted

All rates to be quoted in Kgs/Liters and denomination for packing of items should be as mentioned at items name and declaration of the same should be furnished on bidder's letter head.

**Option Clause** The Contract will have an Option Clause, wherein the Buyer can exercise an option to procure an additional 50% of the original contracted quantity in accordance with the same contract & conditions of the present contract. This will be applicable within the currency of the contract. It will be entirely the discretion of the buyer to exercise this option or not.

**Staggered Delivery of Item** Delivery will be undertaken in staggered manner as per supply order. The delivery period, by which the items are required by the buyer, will be mentioned in each supply order raised on the seller, based on the contract period of 730 days.

**Performance Bank Guarantee** Performance Security Deposit payable to the purchaser is furnished by the supplier in the form of Performance Bank Guarantee (PBG) issued by a Public sector bank or a Private scheduled commercial bank in the prescribed format within 30 days from the date of contract. The Performance Security Deposit is meant to compensate the contract. Preferably, performance security is payable by the supplier at the rate of 5% of the contract value. PBG should remain valid for a period of 60 days beyond the date of completion of contractual obligations including warrant. PBG returned to the supplier on successful completion of all his obligations under the contract. In case the execution of the contract is delayed beyond the contracted period and the purchaser grants extension of delivery period, with or without LD, the supplier must get the PBG re-validated, if not already valid.

All terms and conditions of GeM bid and additional documents uploaded in quality assurance document be clearly read before quoting. Ink signed copy of duly filled additional documents and GeM bid to be uploaded with technical documents. Any violation in terms and condition of additional documents and GeM bid documents by firm would result in disqualification of firm at technical stage.

If the L-1 firm withdraw its offer during tendering stage may be awarded tender holiday for a period of two (02) years. Firm's who emerged as L-1 and subsequently withdrawn its offer within two years will not be eligible for participating in this bid.
