2. The product submitted during the Technical Evaluation will be retained till finalization of the bidding process.
3. The selected bidder has to deliver their materials at the Provincial Store, 4th Assam Police Battalion, Ka

hilipara, Guwahati.

4. The participating bidder should submit latest test report (i.e. prior to 6 months from bid end date) complete in all respect from NABL accredited lab.

5. The Bidder should submit proper documents against the clauses mentioned in the Buyer added Bid Specific Terms & Conditions.

6. The bidder must have prior experience in supplying same or similar category of riot equipment to Police department or other Govt. Law enforcement agencies.
