6. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. **1) Pricing:** - Prices are firm and fixed till delivery of material to MDL Stores.

**2) Item/Scope of Work (SOW):** - The detailed SOW Design, Construction, Fabrication, Erection, Testing, Commissioning & Supply of Fire Water cum Foam Tender as per details mentioned in the technical specification/Gem bid.

**3) Delivery:** Delivery date of items shall be as indicated in GeM Tender. The delivery of complete vehicle up to Mazagon Dock Shipbuilders Ltd, Dockyard Road, Mumbai-400010 is under the scope of supplier within 180 days after placement of order. For details refer technical specification/Gem bid.

The successful tenderer will be solely responsible for the safe custody and proper maintenance of the chassis or any part thereof till the fabrication is completed and vehicle is handed over to MDL (After successful testing at manufacturer premises). For details refer technical specification/Gem bid.

(i) Submission of detailed drawing after placement of order by seller- 20 days.

#### **4) Bid Rejection criteria**

(i) Bids of the Bidders who are debarred under PPP MII order 2017, GeM, CPPP including Tender holiday issued by MDL shall be rejected.

(ii) Bids received without EMD (other than those who are exempted from payment of EMD).

(iii) Bid Non-compliance/non-acceptance to any of the terms and conditions of the tender shall be liable for rejection.

(iv) Any deviation in delivery period shall also falls under liable for rejection.

#### **5) Pre-qualification**

(A) Commercial Pre-Qualification

I. The average annual financial turnover of 'The bidder' during the last three years, ending **31st March 2025 should be at INR 22,50,000.00/-** as per the annual report (audited balance sheet and profit and loss account) of the relevant period, duly authenticated by a chartered Accountant/Cost Accountant in India.

NOTE:

a) Start-ups shall be given 100% relaxation in prior turnover and prior experience subject to meeting of

quality and technical specification.

b) MSE shall be given 100% relaxation of prior turnover and prior experience subject to meeting of quality and technical specifications.

**6) Guarantee/warranty Requirement:** The successful tenderer will have to furnish a maintenance guarantee, undertaking for service, repairs, replacement, maintenance etc. against any defects in the material used, body, construction, Engine, Pump, P.T.O, accessories etc. for 365 days commencing from the date of supply at MDL on stamp paper. Also, other equipment, material and material of construction or accessories original guarantee / warranty certificates shall be submitted separately for details refer technical specification.

(a) The Supplier cannot absolve their responsibility for warranty of material even though it is inspected by & approved by the inspection authorities.

(b) If the defects are not remedied within a reasonable/stipulated time, MDL may proceed to rectify the defects at the supplier's risk & cost, but without prejudice to MDL's rights under the contract.

(c) During the period of warranty / guarantee if any defect is noticed in the equipment / item supplied, the supplier/ contractor will have to rectify such defects immediately at no extra cost to MDL. For such rectification/repair work, if the supplier needs to take the supplied item/equipment out of MDL (in full or part), the supplier shall submit a separate BG of equivalent amount of value of item being taken out, to cover the cost of item.

**7. EMD-** Bidder shall submit the EMD before tender closing date. Bid Security EMD shall be submitted as mentioned in the GeM bid and as per GeM Terms & Condition. EMD exemption is as per GeM conditions, bidders shall submit valid EMD exemption certificate at the time of bidding. In case valid exemption certificate is not submitted along with the bid then bid will be rejected. In addition to that EMD is exempted for following:

a) Bidders registered with MDL under material group no 0054201. To qualify for EMD exemption, firms should necessarily submit valid copy of the Registration Certificate issued by MDL, for the items for which the offer is being submitted. Firms in the process of obtaining MDL registration will not be considered for EMD exemption.

b) Green Channel Status vendors qualify for EMD exemption. Such firms shall submit valid copy of the Green Channel certificate issued by MoD for the items for which the offer is being submitted in Part-I offer/bid. Firms in process of obtaining this certificate will not be considered for EMD exemption.

c) Common/Deemed DPSU registered vendors qualify for EMD exemption. Such firms shall submit valid copy of the registration certificate issued by DPSUs (other than MDL) for the items /services for which the offer is being submitted in Part-I offer/bid. Firms in process of obtaining registration in the DPSUs will not be considered for EMD exemption. Firm not having valid certificate or certificate in process or other than above category of EMD exemption (including EMD exemption as per GeM conditions) has to submit EMD otherwise their offer will be rejected. ## **8) INSPECTION:**

Stage wise inspection & Third-party Inspection will be carried out for details refer technical specification/GeM Bid.

**Third-party Inspection:-** The vehicle including equipment / material and other required details are to be periodically subjected to inspections by any government registered third party inspections such as TCE (Tata Consulting Engineering) / EIL (Engineers India Ltd.) / TUV / SGS / UL / BVIS / IRS. The certificates so issued are to be handed over to MDL. The entire cost component of third-party inspections shall be borne by the vendor. Though, inspection charges for the inspections carried out by MDL representatives shall be borne by MDL.

(a) The decision of the Inspecting Authority or their representatives, as the case may be, on any question of the intent, meaning and the scope of Specifications / Standards shall be final, conclusive and binding on the Bidder/ Supplier / Contractor.

(b) The Bidder /Supplier / Contractor shall accord all facilities to Purchaser's Inspectors /Nominated Agency to carry out Inspection / Testing during course of manufacture / final testing.

(c) Receipt Inspection: MDL (Mbi) shall carry out necessary inspection of the items on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the Inspection documents submitted by suppliers. Any objection raised by MDL (Mbi) inspection team against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time. Goods accepted by the purchaser at the initial and final inspections in terms of the contract, shall in no way dilute the purchaser's right to reject them later if found deficient in terms of the warranty clause of the contract.

(d) Rejection of the material: Any portion of the equipment found defective/rejected, the supplier shall collect the same at his cost from the MDL Yard, all incidental charges being born by supplier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to the supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover storage charges & any consequential damages, from sale proceeds of such disposal.

(e) Pre-Dispatch Inspection-The Final Stage inspection [as per Clause 6(c)] shall also be considered as Pre-Dispatch Inspection.

The Pre-dispatch inspection shall cover Inspection of packing, signing of challan for correctness of packing, certification for packing having done as per standard norms/international norms shall be mandatory part of scope of work

- E-Way bill certificate as applicable duly acknowledged.
- The item should be delivered during office hours only i.e. 9am to 12 pm and from 1pm till 3pm.

(ii) Unloading of the equipment/ items are to be arranged by supplier.

In case of door delivery orders, the supplier shall direct the transporter to deliver the ordered items without insisting for consignee copy of the Lorry Receipt.
