1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Provisions for workmen compensation, insurance, public liability, property damage, insurance etc. to be ensured by the contractor. Also, safety measures prescribed for working in Extra High Voltage & use of personnel protective equipment must be adhered to.

3. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. Generic

Manufacturer Authorization:Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

5. The system should preferably provide for automatic messaging from a computer in the Control Room to enable the same message to be received simultaneously by the concerned Mobile phone(s).
6. **The Service provider will also indicate the additional features which will be provided free of cost or on payment.**
7. The service provider will raise and deliver a singly monthly bill for facilitating the payment along with the user charges of each Mobile connection mentioned separately annexed to the bill. Lowest 01 will be decided on the basis of the lowest total monthly rental for 24 months.
8. Service Provider shall state documents required before converting existing connections through mobile number portability and any other condition in the offer letter.
9. The rates will be initially valid for two years from the date of offer, but may need to be reduced as per market trend as and when such situation would arise. The rates of all service providers are always on the web sites.
10. The rates quoted shall be including taxes and shall be reviewed annually at the time of extension if so.
11. Call conferencing facility should be provided by the agency free of cost.
12. Soft copy of itemized monthly bill should be provided by the agency free of cost.
13. If services of the agency are found unsatisfactory during the tenure of agency the Medical Superintendent, DCBH reserves the right to cancel the tender at any stage without any further notice and Security Deposit will be forfeited immediately or may impose suitable penalty.
14. EMD for a sum of Rs. 28,392 /- (Rupees Twenty Eight Thousand Three Hundred Ninety Two Only) in the name of Medical Superintendent, DCBH shall submit along with the bid. The EMD of successful bidder will be retained as Security Deposit till the running of the contract.
15. There should be no drop problem during tender period. Company should make all efforts to minimize the same.
16. The successful bidder shall be responsible for smooth functioning of entire Network. Any complaint shall be addressed within **24** hours of reporting. In case, resolving of complaint takes longer than 24 hours, suitable action will be taken.

19. If as a result of post-payment audit, any overpayment is detected in respect of any work done by the company or alleged to have done by the company under the contract shall be recovered by the Department from the company in future.
20. Payment will be made on monthly basis and will be released within one month from the date of submission of bill.

22. All disputes or differences arising during the execution of the contract shall be resolved by mutual discussion falling which the matter will be referred to the Secretary (Law Justice and Legislative affair) Govt. of NCT of Delhi or his nominee for arbitration whose decision shall be binding on the contracting parties.
