If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. ### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 3. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 4. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

### 5. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

### 6. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 7. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 8. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1 The entity should be resident of Maharashtra.

2 At time, if the payment is somewhat delayed by the office, the vendor will be responsible for the payment to the personnel deployed for the period of last 3 months.

3 Bidder's Head office must be situated within the local limits of Pune Metropolitan region Development Authority (PMRDA) for the purpose of providing smooth services better co-ordination with the administration and administrative factors regarding issues related to timely payment of monthly salary to the contractual workers, issues related to monthly subscription towards Government dues such as PF, ESIC etc

4. The bidder must have at least 05 years of experience with the income tax department for providing competent man power services who are well aware of the Income Tax Department.

5 The bidder has to upload a copy of PAN Card, GST Registration Certificate & latest paid sensitivity and confidentiality of department's office work Challan and ISO Certificate

6 Minimum Average Turnover/Gross receipts of the entity should not be less than 100 lakhs (1 Cr.) in the last three years. The Bidder must provide copies of ITR, Audited balance sheet and P & L account for the last 3 years to verify financial capacity.

7 The Bidder must Attach supporting documents for the above-mentioned Terms & Conditions.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
