1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 4. 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period

shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. After award of contract – Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing– the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

3. **Generic**

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 5 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.

4. **Buyer Added Bid Specific ATC**

1. **BID-QUALIFICATION CRITERIA:**

BPCL would like to qualify vendors for undertaking the above work as indicated in the brief scope.

Detailed bid qualification criteria for short listing vendors shall be as follows:

- a. **)The Bidder or its OEM {themselves or through re-seller(s)} should have supplied "One number of tank truck tester " , in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of the Documentary evidences of supply shall be uploaded with the bid for verification by the Buyer.**

The following documents should be submitted in support of the Technical Criteria requirement as

mentioned above: -

- 1. Signed Agreement/PO copy/Work order/LOI or any other document which shows value of awarded works along with BOQ.**

The bids may be submitted by:

I. An Indian bidder. The bidder should have completed 3 financial years after date of commencement of business as on due date of the tender.

II. Only Class-I and Class-II Local Supplier as per PP-LC policy issued by MoP&NG, Govt. of India and other clarifications/ notifications/ circulars /amendments issued from time to time in this regard.

III. JV/Consortium bids will not be accepted (Qualification on the strength of the JV Partners/Consortium Members will not be accepted).

Bidders who do not satisfy the above conditions will not be considered for evaluation and ordering.

3. EVALUATION METHODOLOGY:

This tender will be invited through Open tender (Domestic) as two part bid. The bid qualification on evaluation of the received bids will be done as per the above bid qualification criteria and the technical criteria of the shortlisted bidders will be evaluated subsequently. The price bids of the bidders who qualify BQC criteria & meet Technical / Commercial requirements of the tender will only be opened and evaluated.

The order will be placed on the overall lowest successful bidder considering Public Procurement (Preference to Make In India) (PPP-MII) policy for the job. The subject job is Non-Divisible (for PPP-MII purchase preference).

BPCL reserves the right to seek technical queries as well as BQC queries simultaneously during evaluation of bids so that time can be saved in total procurement cycle.

4. EARNEST MONEY DEPOSIT (EMD):

5. PERFORMANCE SECURITY DEPOSIT:

Following 02 options are available with Successful bidder for submitting Security Deposit / Deduction of Retention money.

1 Option A:

Successful bidder can submit the Performance Security Deposit of 5% of basic contract value upfront within 15 days from the receipt of LOA. Retention money shall not be deducted from running bills in such cases.

2 Option B:

Successful Bidder opting for deduction of retention money from running bills shall have to submit the Performance security deposit of 2.5% of basic contract value within 15 days from the receipt of LOA.

Retention money shall be deducted from each running account bill at the rate of 5 % of basic bill value till overall amount (security deposit + retention money deducted) of

5 % of contract value is collected.

Upon request from vendor, security deposit amount will be returned, subject to availability of balance retention money of an amount equal to 5 % of basic contract value, after the refund of security deposit to the vendor.

In above mentioned both options performance security deposit / security deposit submitted in the form of Bank guarantee, the Bank Guarantee shall be valid and remain in force till the contractual completion period, defect liability period and with a claim period of six months thereafter. The Bank Guarantee shall be in the form prescribed in GCC.

6. ATC CLAUSES :

Bank guarantee of 5 % of contract value has to be submitted by vendor to BPEC and will be retained till six month of completion of work . However, where the party opts for performance security in the form of retention money from the running bills, in such case the party shall be required to submit 2.5% of the contract value after setting off EMD submitted, if any, within 15 days from the from the receipt of LOA and the remaining performance security shall be collected in the form of retention money.

As per the latest amendment in August 2023, all the businesses registered under the GST Act, with a total turnover exceeding Rs. 5 crores, are required to generate an e-invoice. Vendor to s

submit E invoice proof in such case . Vendor to strictly follow this else his invoices will not be processed by BPCL .
