1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 1. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

2. Buyer Added Bid Specific ATC

1. The item being procured is of proprietary nature of OEM M/s Jyoti Limited. Bidder shall submit valid authorization certificate from OEM along with their offer. In the absence of such authorization, their offer shall not be considered.

2. Scope: as per bid document.

3. Payment Terms: -

a) For supply portion: 80% of PO value for supply portion plus 100% taxes towards supply portion, shall be done within 30 days against receipt and acceptance of complete material. Balance payment i.e. 20% shall be done within 30 days after successful Replacement/Retrofitting, Testing and commissioning of the Breakers. However, if Replacement/Retrofitting, Testing and commissioning gets delayed for reasons attributable to NFL, then balance 20% payment of supply portion shall be released after 12 months from the date of receipt and acceptance of material at site, against submission of unconditional Bank Guarantee (format as per Annexure B in the ATC document) of equivalent amount (i.e. 20% of supply portion) with a validity of 01 year.

b) For Service portion (Replacement/Retrofitting, Testing and commissioning): 100% payment including taxes towards Replacement/Retrofitting, Testing and commissioning shall be done within 30 days of successful Replacement/Retrofitting, Testing and commissioning of Breakers.

4. MSME vendor payment through TReDS:

Gol has introduced electronic platform for facilitating the financing of trade receivables of MSMEs from buyers, through financiers, which is termed as trade receivables Discounting System (TReDS). NFL is already registered on RXIL/Invoice Mart/M1xchange TreDS platform.

Bidders upon successful delivery shall submit their invoices along with the mandated enclosures including TreDS details. Upon receipt and acceptance of the supplied material/services and receipt of invoices with the mandated enclosures, NFL shall process the invoice for payment as per details submitted on TreDS platform.

Any unfinanced invoice/s of MSME bidders seeking payment from NFL directly shall be processed as per the standard payment terms agreed in PO/Contract.

All financing cost for using the facility shall be borne by the MSME bidder only.

5. Delivery period mentioned in the bid document is indicative in nature. Bidders can quote minimum delivery period in their offer. If delivery period is not quoted by Bidder in the offer, delivery period as per bid document shall be considered. However, offers with delivery period beyond the delivery time mentioned in GEM bid may be accepted at the discretion of NFL.

The Replacement/Retrofitting, Testing and commissioning job shall be carried out in 1 day per breaker. The same shall be intimated to party 15 days in advance through phone/e-mail. Being shutdown job, second breaker job shall be given after successful completion of first breaker's job.

6. Liquidated Damages (as per GeM GTC): (CP:28o/l)

If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period, until actual delivery or performance, as per re-estimated damages not exceeding 5% of the total contract value without any controversy/dispute of any sort whatsoever. However, in case of inordinate delay maximum deduction shall be 10% of the total contract value.

Note: Inexcusable delays of more than one-fourth (25%) of the completion period specified in the contract shall be treated as inordinate delay(s).

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
