2. BIDDER MUST HAVE REGISTERED OFFICE AT THE CONSIGNEE LOCATION. PROOF FOR THE SAME MAY BE UPLOADED FOR TECHNICAL QUALIFICATION.
3. BIDDERS MUST VISIT THE SITE AND INSPECTION FOR THE SAME IS TO BE DONE TO UNDERSTAND THE EXACT SOW, CONDITION OF THE SITE AND ACCESS THE OBSTRUCTIONS WHICH MAY IMPEDE THE SCOPE OF WORK.
4. THE BIDDERS MUST HAVE COMPLETED AT LEAST THREE WORKS WRT THE LANDSCAPING MINIMUM VALUE OF EACH CONTRACT SHOULD BE SEVEN LAKH. PROOF FOR THE SAME IS TO BE ATTACHED FOR TECHNICAL QUALIFICATION.
