**1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**2. Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

**3. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**4. Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

**5. Certificates**

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

**6. Certificates**

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

**7. Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar

proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

#### 8. **Generic**

**Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

#### 9. **Service & Support**

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

##### **Minimum qualifying criteria for a street light product manufacturer/supplier:**

1. Bidder should submit UP PWD AAA Certificate, BIS, and CRS Approved Fitting Certifications
2. The bidder should submit a 5-year warranty certificate for the LED street light on OEM letterhead.
3. It is compulsory to upload the factory license of the LED manufacturer along with the BID.
4. OEM must have an in-house NABL lab in its manufacturing plant; the certificate needs to be uploaded along with the bid documents.
5. OEM should have manufacturing plant in India with In-house NABL Lab, with in-house SMT, MCPCB machine, its Own driver manufacturing unit, a C- and B-type photogoniometer, Automatic assembly lines, etc.
6. The OEM of the offered products needs to submit a declaration on letterhead that the OEM company has not been blacklisted or debarred in any government, semi-government, or PSU department for any reasons as of date.
7. OEM must have ISO 9001:2015, 14001:2015, and 45001:2018 certification.
8. The bidder must submit authorization by the OEM for offered products and an authorization certificate for participating in the specific tender mandatorily to be enclosed with bid documents.
9. The bidder must submit all relevant documents like CRS, BIS, TDS, LM79, LM80, IP, TTC, Photobiology, NABL In-house Lab in its manufacturing plant, Incorporation, and Trademark Certifications.

10. The OEM must have its own manufacturing plant in India (must attach a valid document).
11. The LED street light and its driver must be of the same make for hassle-free service.
12. All bidders are requested to upload all certificates, such as warranty, ESC matrix, and toll-free no., which must have a valid date or be during the tender tenure.
13. OEM authorization certificate is required, along with the employee name, mob, designation, and email or confirming any query or bidder-related information.
14. Both the manufacturer and the supplied product must be registered in the UP PWD CAT AAA Sor; submit it documentary evidence.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
