3. Service & Support

Terms & Conditions for Annual Maintenance Contract (AMC) of Wi-Jungle Firewall

1. Contract Period

1.1 The AMC shall be valid for a period of **36 months** from the date of award of contract.

1.2 Renewal of the contract may be considered based on performance and mutual consent.

2. Scope of AMC

- The AMC includes Firewall Hardware and Software Renewal / maintenance with preventive and corrective maintenance services:

2.1 Hardware Support

- Diagnosis of hardware faults.
- Replacement of defective components/hardware(if covered under OEM warranty).
- Coordination with Wi-Jungle/OEM for RMA cases.

2.2 Software Support

- Installation of firmware updates and security patches updates.
- Backup and restoration of configuration files.
- Assistance in policy updates in firewall software, URL filtering rules, firewall policies, VPN settings, etc.

2.3 Preventive Maintenance

- Quarterly scheduled visits for system health check.
- Log analysis, rule optimization, and performance monitoring.

2.4 Corrective Maintenance

- Troubleshooting and resolving system errors, configuration issues, and performance degradation.
- On-site visits as required for major issues.
- 24x7 remote support for critical issues (if part of SLA).

3. Exclusions from AMC

The AMC shall not cover:

- Physical damage due to mishandling, fire, theft, water, or natural calamities.
- Tampering or unauthorized changes made by third parties.
- Replacement of hardware not covered under OEM warranty.
- Network infrastructure failures outside the firewall (ISP issues, switches, servers, etc.).
- Major redesign of network architecture (chargeable if required).

4. Service Level Agreement (SLA)

4.1 Response Time

5. Support Availability

5.1 **Remote Support:** Available 24x7 for critical issues; 9:00 AM–6:00 PM on working days for routine issues.

5.2 **On-site Support:** Provided during office hours or as mutually agreed.

5.3 Support must be provided by certified Wijungle/network security professionals.

6. Vendor Responsibilities

- Maintain a log of all service calls and preventive visits.
 - Keep all configuration data confidential.
 - Provide monthly or quarterly reports on firewall health and security threats.
 - Inform the client of major vulnerabilities and updates.
 - Ensure minimal downtime during upgrades or maintenance.

7. Client Responsibilities

- Provide network access, required permissions, and physical access to the firewall.
 - Promptly report issues to the vendor.
 - Avoid unauthorized changes to firewall configuration.
 - Maintain proper environment (power, cooling, rack space).

8. Payment Terms

- Payment will be made after successful renewal of the licence for 3 years.
 - Payments are subject to satisfactory service reports.
 - Taxes included as per applicable laws.

9. Warranty of the Networking Device (Wi-Jungle Firewall)

The networking device (Wi-Jungle Firewall) shall be under warranty period for 03 years. In case of any fault or hardware failure; the vendor shall be responsible for replacement, installation and configuration the faulty networking device with new one at their own cost. No additional payment shall be made for replacement, installation and configuration of networking device.

In case the vendor, fails to fulfil the warranty clause, the performance bank guarantee shall be forfeited by the Institute.

10. Confidentiality

- Vendor shall maintain strict confidentiality of network data, logs, credentials, and configurations.
 - No information shall be shared with third parties without written consent.

11. Termination

The contract may be terminated if:

- SLA violations exceed acceptable limits.
- Breach of confidentiality.
- Non-performance despite written warnings.
- Either party provides **30 days' notice** for non-default termination.

12. Liability

Vendor shall not be liable for indirect losses or data loss caused by:

- Power issues, natural disasters, cyber -attacks from external sources, or client misconfiguration.
Liability is limited to the value of the contract.

13. Ownership of Software & Configuration

- All configurations remain the property of the client.
- Vendor must return updated configuration backups at the end of the contract.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
