1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.
5. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would

be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

ADDITIONAL TERMS AND CONDITIONS FOR ELIGIBILITY

- The Physical copy of the EMD Should be submitted to the Gautam Buddha University, Greater Noida, Uttar Pradesh well before the end date/opening date of the bid. MSE category, only manufactures for goods and service provides for services are eligible for exemption from EMD. The bidder seeking EMD exemption, must submit the valid supporting document for the relevant category as per the exemption clauses on GEM.
- Working Experience: Three Similar Satisfactory Completed Works, out of last four financial year, in Central Govt. or State Govt. Organization / Institution, PSU's OR Private organization/Institution, each three costing not less than the amount equal to 40% of the estimated cost Or Two of 50% Or One of 80%
- Audited balance sheet counter signed by C.A. for three years out of last four financial years clearly indicating turnover and T.D.S. Average financial turnover should be at least 50% of the estimated cost during the last three financial years out of last four financial years.
- Attach EPF, ESIC, PAN, GST/IGST Registration Certificate Xerox copy.
- Solvency Certificate Only : Equal to or higher than 40% of the estimated cost. Solvency duly certified by Nationalized/Scheduled bank and issued not before six months (liquid asset/bank statement/bank certificate shall not be considered)
- List of Technical staff with their qualification professional experience and length of the service with the firm Affidavit duly notarized on min. Rs. 10/- non judicial stamp paper.
- Never Black-listed affidavit : The vendor shall submit an affidavit (duly notarized) on Rs.10/- stamp paper

as per below format (***the affidavit issues date/notarize date should not be earlier than the bid publication date***):

“I/We hereby confirm and declare that M/s. proprietor/partner(s) is/are not blacklisted/de-registered/debarred by any Government department/Public Sector Undertaking, Universities, Institution and College or any other reputed organization for which we have executed/undertaken the works/services during the last four financial years

8. Sub-judice Matter Clause : The bid of the participating firm shall not be considered, If any matter of the bidder against the University is sub-judice in any Court of Law.
9. Notwithstanding anything contained in the draft, in case of any dispute, ambiguity and interpretation of any provisions of the draft, the decision of the Competent Authority of the GBU shall be final.

SPECIAL TERMS AND CONDITIONS

1. The quantities taken in the BOQ for each item of work are indicative and may vary either side which no claim shall be taken.
2. The bill shall be prepared on the basis of actual execution of work as per site requirement and measurement of item of work.
3. All the item of work shall be carried out as per the direction of Engineer Incharge including supply of all materials, labour, T&P etc. required for proper completion of the work.

4. PENALTY CLAUSE :

-

Performance Deficiency

Failure to execute assigned sewer maintenance activities, including desalting, cleaning minor repairs, or proper operation of sewer lines /STP, shall attract a penalty of Rs. 500 per day per location for non-execution or unsatisfactory performance.

Maximum penalty Limit

The total penalty imposed under this contract shall not exceed 10% (Ten percent) of the total Accepted Contract Value.

Recovery of Penalty

The Penalty amount shall be recovered from Monthly /Running Bills, or Security Deposit, or

Any other amount payable to the Contractor under this or any other contract.

Compensation for Damages

The Contractor shall be fully responsible for any damage to Property, Sewer assets, Public or private utilities, or Injury to persons, Arising due to negligence, poor workmanship, or non-performance. The cost of such damages shall be recovered in addition to the penalty.

Risk & Cost Clause

In case of continued failure or emergency situations, the Engineer-in-Charge shall have the right to get the work executed through another agency at the risk and cost of Contractor, and the expenditure incurred shall be recovered from the Contractor's dues.

Safety & Statutory Compliance Penalty

Failure to provide necessary PPE, violation of safety norms, or non-compliance with Labour Laws, EPF, ESI, and statutory provisions shall attract penalty and may also land to suspension or termination of the contract.

Decision of Engineer-in-Charge

The decision of the Engineer-in-Charge regarding levy, quantum, and recovery penalty shall be final and binding on the Contractor.

FOR SEWER MAINTENANCE WORKS

If the Contractor fails to maintain required progress or to complete the Sewer Maintenance Works within the stipulated period, the Engineering -in-charge shall, without prejudice to any other right or remedy available under the contract, be entitled to levy compensation/ Liquidated Damages.

Hindrance Conditions

No compensation shall be levied for the period during which the site is not available or work is hindered due to reasons attributable to the Department.

In case of partial hindrance, the Engineer-in-Charge shall assess the proportionate progress achieved during hindrance-free time and levy compensation only if actual progress is less than the admissible pro-rata progress.

Essential Nature of Sewer Maintenance Work

Sewer maintenance is an essential and emergency service. In cases of sewer choking, overflow, leakage, health hazard, or public nuisance, failure of the Contractor to take immediate action shall entitle the Engineer-in-Charge to get the work executed through any other agency, and

recover the cost incurred along with applicable compensation from the Contractor's bills or Security Deposit

Penalty for Delayed / Non-Performance of Sewer Maintenance Works Service Delay / Non-Response

If the Contractor fails to attend sewer complaints, choking, overflow, leakage or service requests within the stipulated response time (normally within 24th hours), a penalty@ 1% of the monthly or 0.25% per week as decided by the Engineer-in-Charge payable amount shall be imposed for each instance of default.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
