ELIGIBILITY CRITERIA

A. TECHNICAL ELIGIBILITY CRITERIA:

1. The bidder should be Original Equipment Manufacturer or the bidder should be OEM's Authorized Dealer / Authorized Channel Partner / Authorized Agent.

[Bid Specific Authorization issued by the Manufacturer (OEM) shall be submitted].

2. The bidder should have successfully supplied and operationalised at least 01 no. Telehandler of minimum 5000Kg Capacity or higher capacity with tyre handling attachment to any Central/State Government Organisation/PSU/Joint Venture Company where at least one of the Partners shall be central or State Government Organization or PSU / Public limited company during last 07 years ending last day of the month previous to one in which NIT is invited.

The bidder shall submit following documentary evidence in support of the above:

I. Copy of purchase order[s] /Contract Order [s] either in the name of the OEM/ OEM's Authorized Dealer / Authorized Channel Partner / Authorized Agent indicating quantity of Telehandler.

II. Corresponding Performance Certificate / Commissioning Certificate/Final acceptance certificate/ Job completion certificate from purchasing organisation.

B. FINANCIAL ELIGIBILITY CRITERIA:

The average annual financial turnover of the bidder during last three (3) consecutive financial years ending 31st March 2025 should not be less than Rs.1.20 Cr. Net worth of the bidder should be positive as per the Audited annual accounts in the latest financial year of the three financial years considered for turnover.

Bidders are required to furnish relevant information regarding name of the customer, contact details, supply order reference, date of commissioning, hour already worked and present status.

14. The bidder have to prove to the satisfaction of SAIL, that they have already established after sales service, parts network and repair facilities in suitable place / places in India. The relevant details must be furnished by the bidder. Manufacturer / their agent / dealers in India are required to have well established sales service / parts network and repair facilities in India, details of which should be furnished.

15. The bidder shall give an undertaking that they shall ensure supply of spare parts and service support for life-time [10 years] operation of the equipment. In case if there is a failure to sustain the same, then the successful bidder has to comply with the following :

- i. The successful bidder shall give sufficient advance notification to SAIL,RSP regarding termination of spare parts supply so as to allow procurement of needed requirement in advance.
- ii. The successful bidder shall furnish at no cost to SAIL, the drawings and specifications of the spare parts.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
