If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- i. Bidders are required to submit EMD of Rs. 1,42,077 in favour of Munitions India Limited O. F. Khamaria. Exemption will be given to the sellers as defined at Para m of GeM GTC 4.0 (Version 1.14) dated 31/01/2024. Further it is mentioned that service of hiring of semi-skilled workmen is related with NIC code No. 78 (Employment Activities) and hence EMD will be exempted for those MSME which are registered with this particular NIC code. MSME other than this has to submit EMD otherwise their offer will be rejected.

EMD/PSD may be accepted in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the commercial banks and it should be drawn in the favor of CGM or payment online in an acceptable form and the same shall be uploaded by seller in the online bid and hard copy of the same instrument (except online payment) will have to be submitted directly to the buyer within following time limit:

(#) Hard copy of the EMD (Bid security) will have to be submitted directly to the buyer within 5 working days of bid opening, failing which the bid may be treated as incomplete & may lead to rejection of the bid by buyer without making any reference to the seller.

(#) Hard copy of the Performance security deposit (PSD) will have to be submitted directly to the buyer within 30 days of award of contract on GeM Portal.

It is advised that EMD may be submitted through online payment in favor of beneficiary details as given below to avoid postal delays & bank formalities associated with generation and submission of instruments other than online payment. If the seller submits the EMD through online payment mode, then seller shall upload the documentary proof of online payment of EMD along with online bid submission.

Further it is also advised that PSD may be submitted through online payment mode after award of contract on GeM Portal in favor CGM, beneficiary details as given below, and also Indemnity Bonds may be accepted as performance security deposit from central/State PSUs. iii. Bidder firm should have registered office at Jabalpur District Area. Registered office address indicated in relevant certificate issued by NSIC/KVIC/DIC/GST/EPF/ESIC/Office of Labour commissioner will be considered as valid proof of registered office at Jabalpur District Area.

iv. Firm must have executed at least one supply order of minimum 80% of the estimated value, two supply order of 50% of the estimated value and three supply order of 40% of estimated value for providing similar service i.e manpower supply to any

Central Government/State Government or Public Sector Undertaking in the last 03 years. Relevant documents i.e. copy of Contract Order and Execution Certificate/Job Completion Certificate are to be uploaded by the bidder along with bid. (MSEs & Startups are exempted).

v. Average annual turnover of the bidder for the last 03 years ending on 31st March of preceding year (2025) must be at least 30% of the estimated value of the case rounded off to the nearest lakh i.e. Rs. 14.00 lakh. Bidders shall submit Certificate from registered CA indicating the turnover details for last 3 years (2022-23, 2023-24 & 2024-25) along with bid in support of financial capability. (MSEs & Startups are exempted).

vi. Bidders should submit latest copy of registration certificates of MSME certificate along with bid.

vii. Bidders should submit copy of registration certificates of EPF, ESIC, & GST along with bid.

viii. One Bid per Bidder-As per clause no. 29 of GeM GTC on GeM 4.0 (Version 1.22) dated 28.02.2025 bidders must submit One bid per Bidder Declaration" as per attached Format-I, failing which the offer of the bidder will be rejected.

ix. Service provider have to follow recently implemented four labour codes effective from 21st November 2025.

x. As per labour Law under section 12 firm has to obtain a license for engaging contract labour working in any establishment 20 or more labours on a day of the month and should submit the same. Also bidder has to arrange rain coat, umbrella, winter jacket etc. whenever required for his worker. No extra charge shall be claimed by service provider for these items.

xi. Bidders has to timely pay salary to its worker i.e on or before 7th of succeeding month.

xii. Bidder has to provide monthly salary slip and ID card to its worker.

xiii. If the workers are employed on national holiday, double salary on that day has to be paid by the contractor.

xiv. CA audited balance sheet (Profit & Loss) to be submitted for the last 3 financial year i.e. 2022-23, 2023-24 & 2024-25.

xv. Firm should deploy only 12 skilled manpower no extra person will deploy in case of absentee of above, Further The personnel being deployed shall be continued and should not be changed without prior permission of the Buyer

xvi. The person being deploy must have PVR (Police Verification Report) which is valid for 01 years.

xvii. The person being deploy must having Adhar card linked with mobile no.

xviii. Service Provider shall provide PPEs such & Uniform (colour of dress should be blue and should have clear indication of working area and name of firm in back side of uniform) to the manpower detailed and the contract value shall be including the cost of PPEs & Uniforms.

xix. Bidder shall comply other term & condition as mentioned in scope of work & Ge M GTC.

xx. Payment Terms:- Payment shall be made on submission of:-

- a. 100% Payment against the bill shall be made on monthly basis for the service actually performed on submission of following documents:
 - ii. Satisfactory Job completion certificate issued by User section representatives.
 - iii. Attendance Sheet (Signed by paying authority)
 - iv. Wage disbursement certificate for payment certified by paying authority nominated by OFK for all the contract.
- b. 100% payment toward government contribution of EPF and ESIC (wherever applicable) will be reimbursed on actual basis, on submission of EPF and ESIC Challan along with the copy of EPF and ESIC return and other relevant documents.
- c. 100% GST will be reimbursed on submission of GST invoice along with the relevant documents.
- d. Monthly payment of Workers will be sent to their individual bank account by contractor and he will give proof of the same to the OFK representatives nominated for the contract before 7th of every month.
- e. Regarding genuineness of EPF remittance the firm representatives will also have to come to factory and show the details on EPFO web page to factory representatives who will take a printout evidence
- f. In case the Agency fails to pay the wages/short payment by 7th of the following month, then the OFK, on the basis of certificate issued by paying authority will pay the wages/difference of short payment to the workers employed by the agency. The expenditure incurred by OFK on account of payment of the wages/difference of short payment to the workers shall be recovered from the bill of the Agency along with the penalty which will be not less than 5% of the bill amount.

Xxi. Termination & Penalty clause-

Penalty will be imposed if the firm fails to perform satisfactorily work as per check points in the following manner:-

- I. Penalty will be imposed 1% of total value of contract of one working day for one deviation in check points daily, 3% weekly, 6% fortnightly & 10% monthly.
- II. If more than 50 deviations in a month, then performance notice will be served to the firm,
- III. If the firm gets 03rd adverse performance notice, the contract may be short closed.
- IV. Penalty will be imposed in case the attendance goes below 90% on any working day. The formula to impose penalty will be as under:-
(Number of worker falling short 90% attendance) X (twice the daily wages of worker)

Xxii. Chief General Manger reserves the right to suspend the contract at any time without assigning any reason.

Xxiii. In case of unsatisfactory performance/service, the contract will be liable to be terminated at any time 7 days' notice and in addition, a penalty up to 10% will also be levied, at the discretion of Chief General Manger.

Xxiv. Risk and purchase clause: - Applicable, If the firm fail to complete the work with in delivery

period, factory reserve right to complete the same at firm's risk and cost.

Xxv. Price Variation Clause is applicable. In case of any changes in the minimum wages as per the Applicable Laws during the Contract period, Buyer shall pay the Service Provider the difference in wage from the amount mentioned in the contract on pro rata basis

Xxvi. Option Clause- 50% applicable.

B. In case of multi L-1 offers, "Run L-1 Selection" tool provided by GeM system may be used and the contract will be awarded to GeM system selected L-1 firm with existing terms & conditions.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in
