1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. B) MINIMUM ELIGIBILITY CRITERIA

The following shall be the minimum eligibility criteria for selection of bidders:

1. Experience and past performance:

a) For MSE/Start-up firm : Capability -Equipment & Manufacturing Facilities : The bidder firm should have capability to manufacture and supply of tendered item.

b) For other firm : Experience and Past Performance : The bidder firm may be Manufacturer/Proven supplier/authorized dealer or distributor of tendered item or bidder may participated with manufacturing a uthorization form (issued by manufacturer of tendered item).

i) Bidders to submit ZED and LEAN certifications by Quality Council of India.

If not available, bidders are encouraged to apply for ZED & LEAN certifications by Quality Council of India.

ii) Anti-Bribery Management System (ABMS) : By participating in this tender, the suppliers /Vendors / Contr actors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice an y such incident happening, they shall report it to Vigilance.
