3. Registration/Empanelment Requirement : Contract shall be awarded to only such sellers, who are registered/empanelled/approved/enlisted with PF and ESIC for required goods/service category on the date of bid opening. The bidder has to produce latest payment document of ESI, EPF & GST.
4. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

8. The bidder should have registered office in state of Assam with valid GST Registration Number of Assam state and Trade License.
9. The upper age limit shall be 35 years. No relaxation in age shall be permissible.
10. Proficiency in Official languages of 4 states (Assam, Arunachal Pradesh, Meghalaya, Sikkim) is desirable in addition to Hindi and English languages.

भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
