1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

ADDITIONAL TERMS & CONDITIONS (ATC)

Procurement of 12 m High Mast Lighting Systems

This bid is invited by the **Taluk Panchayat** for the procurement, installation, te sting, and commissioning of **12 metre High Mast Lighting Systems** for public lighting purposes within the jurisdiction of the Taluk Panchayat, Sindagi, Vijayapura, Karnataka.

The procurement aims to enhance **public illumination, safety, and visibility** . These **Additional Terms & Conditions (ATC)** shall be read in conjunction with the **General Terms and Conditions of GeM** , and in case of any inconsisten

cy, the **GeM provisions shall prevail.**

1. Scope of Supply

The successful bidder shall supply, install, test, and commission **12 m Mini Mast Lighting Systems** strictly as per the specifications mentioned in the GeM Bid/BOQ.

The scope includes:

- Supply of High Mast poles
- Supply of LED flood lights
- Mounting structures, brackets, fasteners
- Internal wiring, earthing, and accessories
- Installation and commissioning (where applicable)

2. Technical Specifications

- Height: **12 metres**

3. Standards and Compliance

1. All materials shall conform to applicable **BIS / ISI standards** and relevant Government norms.
2. LED luminaires shall be **energy-efficient, outdoor-rated**, and suitable for continuous operation.
3. Poles and accessories shall be suitable for local environmental conditions.

4. Quality and Safety

1. All items shall be **new, unused, and free from manufacturing defects**.
2. Proper electrical safety and earthing shall be ensured during installation.
3. Installation shall comply with applicable safety regulations.

5. Quantity

Supply shall be strictly as per the quantities specified in the Bid/BOQ. Partial supply shall not be accepted unless approved by the Buyer.

6. Packaging and Transportation

All materials shall be properly packed to prevent damage during transit. Any damage shall be the sole responsibility of the supplier.

7. Delivery and Installation Schedule

Delivery and installation shall be completed **within the period specified in the GeM bid**.

Delay shall attract **penalties / liquidated damages** as per GeM provisions.

8. Inspection and Acceptance

All materials and installations shall be subject to inspection by the **Consignee / Authorized Officer**. Items not conforming to specifications shall be rejected and replaced at the supplier's cost.

9. Warranty

The supplier shall provide a **minimum warranty as specified in the GeM bid** for luminaires, poles, and related components.

All defects during the warranty period shall be rectified or replaced **free of cost**.

10. SERVICE LEVEL AGREEMENT (SLA) - MAINTENANCE & SUPPORT

10.1 Service Support Arrangement

The bidder shall ensure the availability of **authorized service support or trained service personnel within the district or neighbouring district** to provide timely maintenance and rectification during the warranty / AMC period.

10.2 Complaint Response Time

- Complaints related to malfunction or non-functioning of lights shall be **acknowledged within 12 hours** of intimation.
- Site visit and diagnosis shall be carried out **within 24 hours**.

10.3 Rectification Time

- Minor faults shall be rectified and functionality restored **within 48 hours** of complaint registration.
- Major faults requiring replacement of components shall be rectified **within 72 hours**, subject to availability of spares.

10.4 Downtime and Penalty

- Any downtime beyond the stipulated rectification time shall attract **penalties as per GeM and GFR provisions**.
- Repeated failure to meet SLA requirements may lead to **termination of contract and other actions as per GeM rules**.

10.5 Preventive Maintenance

The supplier shall carry out **preventive maintenance** during the warranty / A MC period as required to ensure uninterrupted operation of the lighting systems

11. Compliance with Government Rules

The supplier shall comply with:

- **GeM procurement guidelines**
- **General Financial Rules (GFR), 2017**
- Applicable electrical safety regulations

12. Payment Terms

Payment shall be made only after successful delivery, installation, inspection, and acceptance.

No advance payment shall be made.

Payments shall be processed through **GeM / PFMS**.

13. Penalty and Liquidated Damages

Penalties for delay in delivery, installation, or service shall be levied **as per GeM and GFR provisions**.

14. Cancellation of Bid

The Buyer reserves the right to cancel the bid at any stage prior to placement of order, for **valid and recorded reasons**, in accordance with GeM guidelines.

15. Termination of Contract

The Buyer reserves the right to terminate the contract in case of:

- Non-compliance with ATC or SLA
- Repeated failure to meet service response times
- Supply of inferior or non-standard materials

Termination shall be as per GeM terms.

16. Buyer's Rights

The Buyer reserves the right to:

- Accept or reject any bid
- Modify quantities within permissible limits
- Take appropriate action in public interest as per GeM rules

17. Buyer's Rights

- i. Bidder's Turn-over
- ii. Acceptance of ATC terms and conditions duly signed by bidder with seal.

iii. Service support undertaking.

Note:

These ATC are **supplementary** to GeM's General Terms & Conditions. In case of conflict, **GeM conditions shall prevail**.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid

template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
