1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. All existing statutory regulations of Central Government shall be adhered to by the service provider/contractor and all records maintained thereof shall be available for scrutiny by this office. Any failure to comply with any of the above regulations or any deficiency in service will render this contract liable for immediate termination without any prior notice.
2. The bill shall be submitted by the service provider/contractor on or before 5th day of the following month. At the time of submission of bill for payment, the contractor/service provider should submit the proof for the previous payment made towards statutory liabilities. The service provider/contractor shall make only statutory deduction from the wage paid to the personnel. Payments shall be made only to the contracting agency and on monthly basis as per actual services. The service provider/contractor has to raise invoices in the first week of the next month for the services rendered in the relevant month. The department shall make payment according to the availability of the funds.
3. The persons engaged by the Contracting Agency/Service Provider will be in the employment of the Contracting Agency/Service Provider only. There will not be any employer-employee relationship between the persons deployed by the service provider/contractor and the Income-tax department. Department/office will not involve in any dispute between the service provider and workers of the service provider/contractor.
4. The service provider/contractor shall indemnify and keep this office indemnified against all acts of omission, negligence, dishonesty or misconduct of the personnel engaged and this office shall not be liable for any damages or compensation to any personnel or third party.
5. All damages caused by the personnel to the property of the office shall be recovered from the service provider/contractor.
6. This office reserves the right to extend the contract further, on the same terms and conditions subject to satisfactory performance of the service provider/contractor.
7. No other person except service provider/contractor's authorized representative shall be allowed to enter the offices.
8. Aadhaar/PAN Numbers of each DEOs and will be verified by the service provider/contractor and they will be allowed to work in this office only after proper police verification.
9. The service provider/contractor shall ensure that workers deployed by it maintain discipline of the highest order and that they restrict themselves to their assigned work only.
10. Any incidence of inappropriate behavior by any of the DEOs and will lead to breach of agreement and will be sufficient cause for termination of agreement if such person is not removed immediately.
11. Notwithstanding anything contained herein, this office reserves the right to terminate the services of the service provider/contractor at any time without giving any notice or reasons whatsoever.

Buyer added specific terms & condition:-

1. The bidder must have a proven track record of providing similar services to a Central/ state Government, or a public sector undertaking (PSU) for a continuous period of three years leading up to the bid opening date. However, preference may be given to such service to the Income-Tax department.
2. EMD in the form of Demand Draft payable at state Bank of India in favor of ZAO CBDT, Surat @ 5 % of contract value along with the bid. The physical copy of the DD must also be submitted at the office of consignee on or before end of the bid period. EMD received after bid period will lead to rejection of Bid.
3. Contractor shall be required to obtain requisite labor license at his own cost from the appropriate Licensing Authority, before undertaking contract work, contractor shall provide proper identification cards for his employees to be deputed by him for / services, duly signed by the contractor or authorized person on behalf of contractor. The contractor will have to carry out police verification of his employee/ security personal and submit a copy of the police verification certificate of security personal to this office.

4. Extension of Contract: The period of contract can be further extended up to the period of six month or more beyond but not more than tenure of one year.

Generic:-

1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 per cent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. BIDDER FINANCIAL STANDING: The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Duration of the service contract may be extended up to 6 months beyond the initial contract duration (Subject to satisfactory performance and mutual consent).

4. CANCELLATION OF CONTRACT: Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the contract or any part thereof by a written notice to the seller, if:

i) The seller fails to comply with any material term of the contract.

ii) The seller informs Buyer of its inability to deliver the material (s) or any part thereof within the stipulated Delivery period or such inability otherwise becomes apparent.

iii) The seller becomes bankrupt or goes liquidation.

iv) The seller makes a general assignment for the benefit of creditors.

v) A receiver is appointed for any substantial property owned by the seller. vii) The seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the purchase order on the seller.

1. AVAILABILITY OF REGISTERED OFFICE OF SERVICE PROVIDER: A registered office of the service provider must be located in Surat City of Gujarat state. Documentary evidence must be submitted with latest renewal/approval of Competent Authority. Must be submitted GST registration certificate to claim registered office in Surat.

2. Dedicated/toll free Telephone No. for service Support: BIDDER/OEM must have Dedicated/toll free Telephone No. for service support.

3. Escalation Matrix for service support: Bidder must provide Escalation matrix of Telephone numbers for Service Support.

4. The service provider is required to have at least 40% of the required manpower on Service provider's Payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
