1. Generic

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any

responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. **Generic**

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

6. **Generic**

Installation, Commissioning, Testing, Configuration, Training (if any - which ever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.

7. **Scope of Supply**

b) Bid Security Declaration in Lieu of EMD: Bidders may submit Bid Security Declaration accepting that if they withdraw or modify their bid during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids document, they may be suspended for the period up to 2 years from being eligible to submit bids for contracts with any procuring entities of DD (R&D) or the bidder would be imposed a penalty equivalent to EMD amount of Rs. 6,78,150.00.

c) Performance Security-cum-Warranty Bond: Successful Bidder can submit Performance Security-cum-Warranty Bond in the form of Bank Guarantee / FDR in favour of 'The Director, Proof & Experimental Establishment, DRDO, Chandipur, Odisha- 756 025' amounting to 5% of contract value. The bond must valid for a period of 60 days beyond the original delivery period plus warranty period. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original Bank Guarantee / FDR to the Buyer within 30 days of award of contract. Failure to submit the bond within the specified timeline shall attract Liquidated Damage (LD) at the rate of 0.5% of the bond amount per week or part thereof of delay. In case the delay exceeds sixty (60) days, the Contract is liable to be cancelled and/ or other appropriate action may be initiated against the bidder as deemed necessary.

d) Liquidated Damages (LD): If the Seller fails to deliver the Goods or not able to complete the job within the Delivery period (DP), Liquidated Damages (LD) will be charged @ 0.5% per week or part of the week of delayed period not exceeding 10% of the contract value.

e) Payment Terms: 100% payment will be initiated within 10 days of issue of consignee receipt-cum-acceptance certificate (CRAC).

Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
