1. Service & Support Availability of Service Centers: Bidder must have a Functional Service Center in the Delhi/NCR only.
2. Contract shall be awarded only after submission of documentary evidence of having a Functional Service Centre at Delhi/NCR.
3. **Generic Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder undertaking to this effect with bid.
4. EMD for Rs. 20,000/- refundable, DD in F/O Pay & Accounts Officer, DPIIT. (Scan copy of DD to be attached in bidding documents).
5. ESIC, PF registration certificate to be attached with the bidding documents.
6. The firm should have at least 40 employees on the rolls as on date whose services have been provided in other offices. (List of employees with ESI & PF number to be attached).
7. The participating vendor should be registered with the Department of Labour, Government of Delhi for providing manpower. The vendor should provide documentary evidence in support of the registration failing which the bid shall not be entertained.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
