1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. 6. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

##### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

##### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

##### 3. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

#### 4. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

#### 5. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 6. **Service & Support**

In the event where the distance travelled exceeds the monthly usage variant, amount will be paid for additional Kms as per schedule. Similarly, the unused Kms in a particular month as against the minimum guaranteed usage variant will be carried forward to the next month and additional Km if any in the next month shall be adjusted against this. However, the payment for the selected usage variant in a month will be paid every month." Further, the unused Kms in a particular month shall not be carried forward or adjusted beyond 6 months

#### 7. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 8. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

#### 9. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

## 14. **Buyer Added Bid Specific ATC**

The following additional terms and conditions shall be read along with the provisions given in the GTC, STC and Miscellaneous Terms and Conditions for the services being offered:

- 1) The Payment shall be made after successful completion of work or on monthly basis.
- 2) Completion period of the work is 12 months for 1 no's vehicle from the date of issuance of LOA; provision of extension up to 25% on satisfactory service to be decided by competent authority.
- 3) It would be Contractor's responsibility to pay any demurrage/compensation arising out of any accident or theft of the office equipment due to the service persons engaged by him. Railway shall not be liable to reimburse any payments if required to be made by the Contractor to any party(s).
- 4) Any Damage to the Railway men and materials due to negligence on the part of contractor or their representative, the damaged cost will be recovered from the contractor or their representative, the damaged cost shall be recovered from the contractor bill as per prevailing market rate/ Railway rate.
- 5) If for administrative or other reasons the contract is transferred to the Successor Railway officials, the contract shall, notwithstanding any things contained herein contrary thereto, be binding on the Contractor and the Successor Railway officials in the same manner and take effect in all respects as if the Contractor and the Successor Railway had been parties thereto from the date of this contract.
- 6) No free Railway passes shall be issued by the Railway to the Contractor or any of her employees/workers. Wherever required authority for entering restricted area or authority for on board services shall be provided.
- 7) Risk coverage of life of the driver deployed by the tenderer for operation of vehicle will be responsibility of tenderer. Railway will not be liable on this account.
- 8) The vehicles should be available for 24 hrs in a day. So, the Contractor should ensure that drivers should be provided for each vehicle with mobile communication facility for contacting. The drivers should be in a neat and descent dress and he shall maintain necessary decorum while on duty. Railway shall not pay a additional cost for this.
- 9) The contractor shall pay parking charge if any and the vehicle should be provided with 'Fastag' for "TOLL" in National Highway or elsewhere.
- 10) Vehicle will be run over Lumding, Rangiya and Tinsukia Divisions of N.F. Railway and states of Assam & Arunachal Pradesh.

11) The Tenderer should possess valid ISO 9001 Certificate. (**Supporting documents must be furnished. Non submission of document will lead to summarily rejection of offer**)

12) The Tenderer should have Performance Certificates given by Government Offices/Public/Private Sector Undertakings/Autonomous Bodies as evidence of providing satisfactory services during the last 3 years. If new bidder, declaration should be mentioned as 'NIL' and to be uploaded. (Supporting documents shall be furnished. Non submission of document will lead to summarily rejection of offer).

13) Tenderer must have local office or branch office at Assam or at Consignee location. Any government utility bill to be submitted as office address proof (BSNL Bill, Electricity bill, Gas bill etc). And if the contractor submits rent agreement, it must be notarised in Assam. (Supporting documents shall be furnished. Non submission of document will lead to summarily rejection of offer).

14) At the time of bidding of contract, the contractor has to upload notarised declaration that the firm is not in the process of liquidation and its liquidity position is favourable. (**Supporting documents shall be furnished. Non submission of document will lead to summarily rejection of offer**).

15) Tenderer at the time of bidding must upload duly signed copy of ATC (each page). Signed copy of ATC shall be uploaded strictly against Certificate (Requested in ATC).

16) Tenderer must submit EPF and ESIC registration certificate with the bid. (Supporting documents must be uploaded with the bid).

17) Tenderer must submit audited balance sheet or turnover certificate by CA for last 3 financial years. (Supporting documents must be uploaded with the bid).

18) It is mandatory for the tenderer to have at least 01 (one) SUV commercial registration vehicles in the name of firm /company/Proprietor/Partner. (**Supporting documents shall be furnished. Non submission of document will lead to summarily rejection of offer**).

19) Contractor must ensure commercial registration from RTO, pollution emission certificate, insurance of the vehicle, valid driving license, road permit (inter/intra/National permit etc as per requirement).

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
