The agency must be registered under the West Bengal Private Security Agencies (Regulation) Rules, 2007 and must be in possession of a valid license under the WB Private Security Agencies (Regulation) Rules, 2007. Those security agencies which are registered in any other states' PSARA rules and not have been registered under the West Bengal Private Security Agencies (Regulation) Rules, 2007 and not in possession of valid MP PSARA license issued under the West Bengal Private Security Agencies (Regulation) Rules, 2007 shall not be considered eligible for the bid and they need not to participate in the bid.

2. Double duty is not allowed under any circumstances and manpower deployed by the service provider must not be allowed to work more than 48 hours a week and the service provider must ensure that during weekly off in respect of every security guard deployed, the Reliever may be deployed accordingly as the contract is for providing security throughout the month for a period of 2 years apart from the extended period if the same got extended.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
