1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

##### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

##### 2. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due

performance of the Contract and the Sellers obligations there under.

### 3. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 4. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

### 5. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 6. **Past Project Experience**

**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.

### 7. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

All of the following details form part of ATC:

1. Vehicle is required as per detail given below:

A) 03 numbers of vehicles (01 Premium Sedan & 02 Sedan) will be required from 01.03.2026.

B) 01 number of vehicle (01 Sedan) will be required from 01.04.2026.

02 numbers of vehicles (01 Premium Sedan and 01 Sedan) will be required from 01.05.2026

The contract shall be valid for a period of one year from the day of award of GeM contract on GeM and can be extended subsequently for a period up to one year on the same rates and terms and conditions on mutual consent, subject to satisfactory services by the Service provider at a time.

3. Bidders should be registered with the Department of Tourism or State Transport Authority as Authorized Transporter/Taxi Operator.

4. The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect on its letter head, **the date of undertaking should be on or after publishing of the Bid and not after the bid opening date.**

5. The Service Provider must provide vehicles in excellent condition (Up to 25,000 Kms travelled) at the beginning of the contract period. An undertaking in this effect is to be uploaded by the bidder. Bidder to upload bid specific undertaking to this effect on its official letter head, the date of undertaking should be on or

after publishing of the Bid and not after the bid opening date.

6. Bidders are required to have minimum 03 Premium Sedan Vehicles (Ciaz or equivalent as per GeM categorization) & 03 Sedan Vehicles (Dzire or equivalent as per GeM categorization) in their existing fleet registered not prior to 2024 in the name of company/director/partner/proprietor. (Vehicle RC to be attached)

7. The firm is required to provide the Bid Security declaration form stating that if they withdraw or modify their bids during the period of validity, or if they are awarded the contract and they fail to submit a performance security, they will be suspended for the one year and will be ineligible to submit Bids/Proposals for contracts with this organization, the date of undertaking should be on or after publishing of the Bid.

9. The bidder should submit an undertaking for no default of PF,ESI payments for last one year and submit salary records atleast three months having ESI/EPF deductions employed drivers in order to verify the antecedents of the drivers who are employed.

10. A Declaration from the bidder on their letterhead stating the drivers provided will be of good character, vetted by police for security, have valid driving license and are aware of the roads of Delhi/NCR will be provided.

11. The bidders are required to upload the notarized declaration on letter head stating that the bidder has not been black-listed by any Ministry/Department/Organization during last five years, **the date of undertaking should be on or after publishing of the Bid.**

12. Financial Criteria: A) The Bidders are required to upload scanned copy of Income Tax Returns for last three financial years (2021-22, 2022-23, 2023-24).

B) The Bidders are required to upload Balance Sheet or Profit & Loss statement or audit reports or turnover certificate for last three financial years (2021-22, 2022-23, 2023-24) duly certified by Chartered Accountant.

13. The bidder should furnish copy of latest annual GST return at least for FY ending on 31.03.2025 (Form GSTR-9) duly certified by Chartered Accountant.

14. The firm must provide documentary evidence in form of satisfactory report issued by concerned Ministry/Department regarding providing atleast 05 vehicles in a single tender in the last three year in any Govt. Ministry/Departments. In the absence of these documents, bid will be summarily rejected.

15. The bidder has to accept all terms and conditions mentioned in the bid document. An undertaking to this effect on the letter head of the firm/company shall be uploaded along with the bid.

16. Buyer reserves the right to upgrade or downgrade the vehicle category i.e. from Premium Sedan to sedan or vice versa during the contract period and payment shall be paid accordingly as per the amount quoted by the bidder for respective category. A prior notice will be given to service provider for implementing the change in category.

17. The contract is for 06 vehicles, however during the period of contract the quantity of the vehicles can be reduced with minimum 03 vehicles. A prior notice will be given to service provider for implementing the change in quantity. The payment will be made based on the services consumed of actual number of vehicles at that time.

18. All the vehicles provided by the bidders shall be commercial only and the drivers must have valid commercial driving license. The services of the vehicle will be for the region of Delhi/NCR, thus the bidder should have prior permission to operate in the region.

19. The service provider shall submit the police verification certificate of the employee driver within 15 days from the date of award of work..

20. The service provider shall ensure that all drivers employed by them wear proper driver uniform during all working days. Failing which, a penalty of Rs. 100 per day/instance shall be levied.

21. Frequently changing of drivers/vehicles should be avoided

22. All vehicles must have an umbrella, good quality seat cover, car freshener, torch, fire extinguisher, first aid kit etc.

23. Failure in providing the service as above will attract penalty in addition to the GeM SLA.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
