**Special terms and conditions-Version:1 effective from 31-10-2025 for category Stationary Valve Regulated Lead Acid Batteries (V3) Conforming To IS 15549**

1. **1.** The battery supply condition (factory charged), material and construction, separators, terminal post, cell lids, plates, electrolyte, connector, designation of cells, charger, flame arrestor, and marking requirements shall conform to the IS 15549 standard.

1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

3. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. **Generic**

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 5 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.

5. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

6. **Buyer Added Bid Specific ATC**

**----- IMPORTANT TERMS & CONDITIONS-----**

**We need specifically 12 Volt 75AH SMF UPS batteries. No other batteries will be considered.** If any bidder participates for this Bid (Other than 12 Volt 75AH SMF UPS battery ) will not considered as qualified for Technical /Financial Bid, and **immediately will be rejected.**

- 1- **Bidder must upload CPRI /STQC certificate for the said product.**

- 2- Batch No. of supplied battery should not older than 3 months, Batch No., date of manufacturing should be mentioned in delivery challan /invoice.**
2. Selected Battery Supplier will replace the old batteries and install the new batteries in the physical presence of the Engineer of UPS Vendor.
- 3- Installation / replacement process of batteries will be carried out by the coordination of respective DIO, NIC to ensure the physical presence of the both the representatives of Battery Supplier & UPS vendor in a same time. UPS Engineer will disconnect the battery bank from UPS and again reconnecting the battery bank to UPS after placement/ installation of new batteries. **Batteries should not be installed without physical presence of UPS Engineer.**
- 4- As this offer is with buy back, therefore dismantling of old existing batteries from UPS will be carried out by bidder/supplier.
- 5- if any battery found derated / defective at the time of checking during the warranty period, it should be replaced with new battery immediately without any charge.
- 6- **Upload only the required/relevant documents, which are essential and mentioned / required in ATC. Old battery (for buy back) : EXIDE Powersafe PLUS 12 V 75 AH = 20 Nos. (Farukhhabad) UP**
- 7- **Warranty of new Batteries should be minimum 24 Months.**
- 8- **Bidder should be OEM/Authorised dealer. Certificate should attached otherwise bid will not considered as qualified for Technical /Financial Bid, and immediately will be rejected.**
- \*\* Since the procurement of the item is in buyback mode, the net payment will be made after adjusting the cost of buy back old/returned batteries.**

#### **अस्वीकरण/Disclaimer**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of

bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
