1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in

India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

3. Generic

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

2. **Eligibility Criteria For this Tender:**

(a) Technical Criteria :

(i) Electrical contractor license: The contractor should have valid **Electrical contractor license** issued by Govt. and submit along with tender document. The OEM or his authorized dealer will be exempted from license.

(ii) Similar Nature of Work for this tender is as under: Supply, Installation and commissioning (SITC) of VRF/VRV system with CAMC/AMC.

OR

Minimum Eligibility Criteria for Work Experience in this work. The bidder should have satisfactorily completed in the last three previous Financial Years and the current Financial year up to the date of opening of the tender one similar single service contract (Comprehensive Annual Maintenance Contract/ Annual Maintenance Contract of Variable refrigerant Flow (VRF/VRV system) for a minimum of 35% of advertised value of bid in Central Government Offices or PSU Offices or State Government Offices or a Public listed Company Work experience Certificate from Private Individual shall not be accepted. Certificate from public listed company/private Company/ Trust having annual turnover of Rs 500 Crore and above subject to the same being issued from Head Office by a person of the company duly enclosing his authorization by the Management for issuing such credentials

(b) Work Experience :-

The bidder should have satisfactorily completed in the last three previous financial years and current financial years up to the date of opening of the tender. One similar single service contract for a minimum of 35% of advertised value of the bid.

Completed service contract includes on-going service contract subject to payment of bills amounting to at least 35% of the advertised value of the bid.

Work experience certificate from private individual shall not be accepted. Certificate from public listed company/private company/Trust having annual turnover of Rs.500 core and above subject to the same being issued from their Head office by a person of the company duly enclosing his authorisation by the management for issuing such credentials.

(c) Financial Criteria:

(i) Financial Turnover (T1): The bidder should have an aggregate financial turnover not less than 1.5 times the advertised Bid value during the last three previous financial years and in the current financial year up to the date of opening of the tender. The audited balance

sheet reflecting financial turnover certified by chartered accountant with her stamp, signature and membership number shall be considered.

(ii) Liquidity (T2): The bidder should have access to or has available liquid assets, lines of credit and other financial means to meet cash flow that is valued at 5% of the estimated bid value net of applicant's commitments for other contracts. The audited balance sheet and/or banking reference certified by chartered accountant with her stamp, signature and membership number shall be submitted by the bidder along with bid.

Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant/member of the Joint Venture/Consortium. In case the Net Current Assets (as seen from the Balance Sheets) are negative, only the Banking references will be considered. Otherwise the aggregate of the Net Current Assets and submitted Banking references will be considered for working out the Liquidity.

The banking reference should be from a Scheduled Bank in India and it should not be more than 3 months old as on date of submission of bids.

In Case of JV firms overall liquidity of JV firm shall be assessed by arithmetic sum of liquidity of all members of JV.

3. The work to be carried out as per IE rules and code of practice.
4. All the Electrical item/cables shall be ISI mark if prevailing.
5. All released material to be deposited to concern field In charge office.
6. Proper shut down to be arranged from concerned SSE of the station.
7. Samples of item to be approved from this office.
8. The location of the work can be changed as per the requirement of Railway in the division.
9. Tender will be governed by G.C.C. for Service Contract as per amended time to time.
10. Vehicle and equipments of contractors can be drafted by Railway administration in case of accidents/natural calamities involving human lives. Payment for the same will be made after operating the items as Non-schedule items, as per the existing norms and power delegated in the SOP of Railways.

11. Whenever laying of cable is to be done across the road/platform/other places, than same should be repaired with Concrete Cement properly.

13. Any contradiction in schedule of rate and specification; final decision of Railway authority will be final as per railway requirement.

15. During representation only bid document/quoted terms & conditions clarification will be accepted. No any documents will be accepted during representation after opening of technical bid.
16. If there is any contradiction between GeM SLA and attached Scope of work, Special terms & conditions any penalty then attached document Scope or work, Special terms & conditions and penalty will be considered finally as per Customized bid.
17. The received rate in the GeM contract will be all inclusive rate for all activities mentioned in the GeM Contract and attached Scope of work. After successfully executed the service contract as per GeM Contract and Scope of work, payment will be made Quarterly basis or mutually agreed.
18. In case of breakdown, the complaint shall be attended within 24 hours of failure intimation (through call, SMS, e-mail, customer care, whatsapp, customer care etc.), otherwise penalty of Rs. 1000/- per item/ per day shall be recovered from the contractor bills.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
