1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid

document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . 5. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. 3. The bidders are advised that before participating in the bid, the bidder can visit the Central Purchase Office during any working days between 11:00 AM to 01:00 PM during the bidding period for any detail specification of the required items.

4. A pair of shoe (02 odds) along with its Technical and Financial Bids to be submitted. One odd of approved sample to be retained by the University and other odd to be returned to the vendor with due approval for production reference.

5. RISK PURCHASE CLAUSE: In the event of failure of supplier to deliver or dispatch the stores or provide the required services within the stipulated dates/period of the supply order/ AT, or in the event of breach of any of the terms and conditions of the AT, the purchaser will have the right to purchase the subject store elsewhere at the risk and cost of defaulting supplier after giving notice to defaulting supplier. The cost as per Risk Purchase exercise may be recovered from the bills pending with the supplier even against any other suppliers outside this contract or even from the pending bills with any other Govt. Department/Ministry. In the event of contract being cancelled for any breach committed and the purchaser effecting repurchase of the subject store at the risk and cost of contractor, the purchaser is not bound to accept the lower offer of Benami or allied sister concern of the contractor.

6. NON-BLACK LISTED CERTIFICATE: Bidder will upload a self- certificate stating that his firm has not been blacklisted by any Govt./PSU agencies in recent past and also not under liquidation /court receivership /similar proceedings. (Note: Format attached as per Appendix-A)

7. MAKE IN INDIA CLAUSE: For make in India preference, preferences will be decided as per latest guideline.

8. PERCENTAGE OF LOCAL CONTENT: The bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid.

9. RIGHT TO REJECTION: Central Purchase Office will be accepted after inspection and only if they are found up to the standard specification. The decision of the Tender Purchase Committee (TPC) / Central Purchase Committee (CPC) shall be final as to the quality of the stores and shall be binding upon the tenderers and in case of any of the articles supplied not being found as per specification shall be liable to be rejected or replaced and any expenses or losses caused to the suppliers should be borne by the supplier and ensured by the supplier that articles supplied should be best in quality and free from all defects. The acceptance of articles will be made only when the articles are inspected and found up to the standard specifications and free from all defects. The rejected stores must be removed by the tenderers from the consignee's premises within 15 days from the date of the intimation about rejection at the risk and cost of the tender. The in-charge stores concerned will take reasonable view of such materials but in no case shall be responsible for any loss, shortage, damage that may occur to it while it is in the premises or the consignee.

10. COMPLIANCE OF SPECIFICATION: Bidder have to upload compliance of specification by mentioning complied/not complied against each parameter.

11. SELF -CERTIFICATE FOR ACCEPTANCE OF ATC IS REQUIRED: The bidder will submit a self-certificate stating that " (write name of firms) is accepting all terms and conditions of the ATC of Bid No.

12. All items (shoes) to be supplied shall strictly conform to the technical specifications, brand, model, size, material, and applicable IS/ISO standards as mentioned on the GeM Portal.

13. Wherever required, the Vendor shall mandatorily submit samples prior to bulk supply. Only the supply strictly matching the sample approved by the Buyer shall be accepted. Any deviation from the approved sample shall render the entire consignment liable for rejection.

14. The Buyer shall have full right to inspect the material after delivery. In case any defective, substandard, or non-conforming material is found during inspection, the Buyer reserves the right to reject the material wholly or partially.

15. Rejected material shall be replaced by the Vendor at his own cost within 07 working

g days. In case of delay or failure, the Buyer shall have the right to cancel the Purchase Order and make alternate arrangements at the Vendor's risk and cost.

16. Timely delivery within the stipulated period shall be the sole responsibility of the Vendor. In case of delay, Liquidated Damages / Penalty as per GeM rules shall be imposed and recovered from the payable amount.

17. Payment shall be made only after satisfactory supply, complete inspection, and final acceptance of the material. Any request for advance payment shall not be entertained.

18. The Vendor shall provide a minimum 03 months warranty on the supplied material. During the warranty period, any manufacturing defect shall be rectified by free replacement, at no extra cost to the Buyer.

19. In case of violation of any terms and conditions, supply of substandard material, or repeated delays, the Buyer shall have the absolute right to cancel the order without any prior notice.

20. In the event of any dispute, the courts having jurisdiction over the Buyer's office location shall alone have jurisdiction.

21. The Vendor shall ensure that the supplied material is 100% identical to what is displayed on the GeM Portal. Any variation in brand, model, size, colour, material, sole, stitching, or finishing at any stage shall result in automatic rejection of the material.

22. On demand by the Buyer, the Vendor shall submit a quality test report from a NABL-accredited laboratory. Failure in the test report shall lead to rejection of the entire supply, and the Vendor shall have no claim whatsoever.

23. If any latent / hidden manufacturing defects are noticed at any time during use or after inspection, the Vendor shall replace the entire material free of cost, even if payment has already been made.

24. Rejected / defective material shall be replaced by the Vendor within a maximum of 05 working days. In case of failure, the Buyer shall have the right to make Risk Purchase, and the additional expenditure incurred shall be recovered from the Vendor.

25. In cases of quality fraud, supply of wrong brand, counterfeit material, or repeated violations, the Buyer shall have the right to recommend Blacklisting / Debarment of the Vendor on the GeM Portal.

26. For delay in delivery, Liquidated Damages at the rate of 1% per week, subject to a maximum of 10%, shall be imposed without any prior notice.

27. In any technical, quality, payment, or contractual dispute, the decision of the Buyer shall be final, binding, and not subject to challenge.

7. Floating / creation of work contracts as Custom Bids in Services.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.

- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**
