If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 1. Scope of Supply

1. All the best engineering practices as per latest engineering standard to be maintained throughout the execution of the job.
2. Inspection shall be as per the BHEL Quality assurance plan.
3. The supplied materials shall be completely interchangeable with the existing ones. BHEL shall give compliance for the same and furnish interchangeability certificate of the supplied material with the existing one.
4. BHEL shall have to stand Guarantee for the materials supplied, for a period of 12 months from the date of commissioning or 18 months from the date of supply or whichever is earlier against any manufacturing defects/ bad workmanship etc. and must replace the rejected material/materials at their risk and cost. A certificate to this effect shall be furnished by BHEL along with the supply.

5. The materials shall be properly packed as per BHEL standards to avoid damage during transit .

6. Payment Terms:

- a) 20% of the PO value shall be paid as interest free advance against submission of proforma

invoice and furnishing of Bank Guarantee of equivalent amount valid for a period upto supply.

- b) Please negotiate your balance 80% bill with applicable GST against dispatch documents through State Bank of India, Namrup Branch, P.O. Parbatpur-786623, Dist: Dibrugarh, Assam, but overdue interest is not payable by the Corporation. You will send an advance copy of your bill for 80% payment along with a copy of complete set of documents and negotiated to our Chief Manager (Finance), Namrup and one more set to the HOD, Materials Management. Bank charges to respective account.

For negotiation of dispatch documents, any condition insisted by the suppliers beyond the scope of the Purchase Order will not be binding on the corporation and the documents are bound to be returned at suppliers cost and risk.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
